A. Rationale and Criteria:

Ron Halbach educated the committee members on the AIA Executive Board's objective(s) and clarified the role of the Advisories committee(s) in the process. He informed committee members of current AIA bylaws/procedures which led the development of the each sports-specific advisory committee.

- 1. October 1st Enrollment counts will determine placement of schools by Conference and Division.
 - a. Schools will be placed into a "Division" and a "Section"
- 2. All schools will use Power-rankings and schedules will be determined by "Computerized Scheduling"
 - a. AIA Exec. Board will determine the "minimum" number of games to be scheduled.
 - b. Schools will be responsible for scheduling any games above and beyond the assigned schedule.

 - ii. TAC will provide feedback and advice (TAC does not make the determination All "opposition" will be reported to the Exec. Board as well.)

D. Division and State Tournament Reconfiguration

Ron Halbach provided handouts outlining the AIA Ex. Board procedures, justifying the Executive Board's decision to reconfigure the state tournament, realignment to Div/Sections, and power rankings.

- 1. Decision based on Financial concerns
 - i. Increased costs to conduct State tournaments
 - ii. Decreased attendance = loss of revenue at state tournaments

- 2. Each school will send <u>2</u> singles and <u>2</u> doubles teams entries to their respective division state tournament
 - i. <u>Individual</u> = (128 slot bracket)
 - i. Only 8 players will be seeded
 - (1.) Controversy over using the USTA criteria as the sole determinate for seeding
 - (2.) TAC would like to establish additional criteria regulating seeding
 - ii. All others will be "Blind Draw"
 - (1.) Players from the same school will be placed on opposite sides of the bracket
 - ii. <u>Team</u> = Brackets will remain the same as in previous years
- 3. Ron will provide more information regarding the brackets when we meet next time
 - a. Ron will need feedback Determining the seeded players
- 4. There is no appeal up or down for this year's "individual" tournament
- 5. Ron will meet with the 1A to determine Criteria for the 1A 'teams' to go to 2011 state tournament"
