State Meet Review:

Recommendations/Conclusions

1. Qualifying marks will be adjusted for next year.

Automatic standards will be set using the average of the 8th place **entered** mark from the 2009 & 2010 state meets.

The Division I provisional mark will be the 36th place **entered** mark from the 2010 state meet.

There will be no provisional mark for Division II, so to guarantee the 32 qualifiers.

Provisional diving standards remain the same as 2010 for 11 dive standards, however, the automatic standards will be dropped.

Only **11 dive programs** can qualify for the state meet.

2. The number of qualifiers per event will be **increased to 32** in the individual events and **remain at 24** in the relays per division.

3. Sanctioned qualifying meets must be on the AIA calendar and must meet the following criteria:

- a. Electronic timing systems
- b. 5 Certified officials minimum – 3 on deck, system 5 or 6, hy-tek operator

- c. Minimum of 5 teams
 - d. Submit a qualifying meet form, prior to and after a qualifying meet.
4. The number of meets allowed will remain at eleven (11) with a maximum of four (4) invitational's.
5. **Each individual school will use Hy-tek Team Manager Software for the 2011 swim season.** The AIA will help coordinate the school's purchase of the software. Team Manager Lite will be **free** for those schools wanting the basic program. Team Manager Bronze and Silver will have additional costs if purchased.
- a. Team Manager will be used to **enter swimmers and divers into invitationals and the state meet.**
 - b. Training will be provided for Team Manager.
6. The Swim Advisory Committee will facilitate the setting of an **Invitational calendar** for swimming.
- a. A **"Invitational Weekend"** will be blacked out one week prior to the state meet to have competition opportunities. All swim programs will be provided the opportunity to compete.
7. The 2011 State Swimming Meet will take place over **two days**, with **2 sessions using 2 pools on prelim Friday and 1 session using 2 pools on finals Saturday.** Saturday's Championship session would start at 12:00 noon.
8. **Diving**
- a. Any diver that **meets** an 11-dive provisional qualifying score at an invitational may **enter** the **State Dive Qualifier Meet to be held on October 20/21, 2011.** From that meet, **32** divers will qualify for the State Meet in each division.
9. The Swimming by-laws were cleaned up and will be submitted for AIA Executive Board approval to the legislative council.
