Minutes of November 14, 2010 meeting review:

Motion to approve, first by Jim Dowse and second by Jim Threadgill no discussion committee approved 6-0.

Agenda Items:

Sectional Tournament Seeding Criteria

- 1. Sections will seed to 6 places**
- 2. Pre-seeding** will be determined by each wrestler's Overall season winning %.
(Wrestler must have wrestled a MINIMUM of (7) seven matches to be seeded)

3. Returning previous **year** Arizona State Champion
4. Head to head competition will determine final seeding positions
(Not just a tie-breaker)

Note: The wrestling round to determine a true second has been eliminated.

Motion to approve sectional seeding criteria, first by Al Trejo and second by Bob Weir approved 5-1. A no vote was cast by Jim Threadgill.

State Tournament Seeding Criteria

The following seeding criteria will be used for all Divisions of the State Wrestling Tournaments.

1. **State will seed to 9 places**
2. **The top (3) three sectional placers will be placed into a (9) nine man pool for seeding consideration**
3. Sectional Champions will always receive a higher seed than their respective runner-ups regardless of head to head competition.
4. **Pre-seeding** will be determined by each wrestler's OVERALL season winning %.
5. Returning previous **year** Arizona State Champion
6. Head to head competition will determine final seeding (exception #3)
7. Seeding criteria for the 16th slot in the bracket will be:
(6th place in the sectional, overall winning %, head to head competition)

Motion to approve state seeding criteria, first by Tim Williams and second by Rocky Nelson approved 6-0.

Motion to have Bob Weir chair the wrestling sports committee, first by Rocky Nelson and second by Jim Dowse approved 6-0

Notes: NWCA weight certification workshops will be held and conducted by knowledgeable coaches within each division/section at the beginning of the season

NWCA wrestling weigh-in sheets will be mandatory for all weigh-ins

The AIA will hold training for the sectional tournament directors / computer scorers
