Approval of the Minutes from March 31, 2011

- Motion to approve by John Chambers, seconded by Gayle Staring, motion passed.

Discussion items:

David Hines, AIA Swimming Tournament Coordinator reviewed the following items:

- The 2011 State Meet Qualifying standards are online on the swim & dive page of AIA365
- Reminder that **32 individuals** will qualify per event this year. Relay teams will qualify **24 teams**.
- Any school interested in hosting a state qualifying swim meet must submit an application packet to David Hines at the AIA to be approved and listed as an official qualifying meet. That packet will be found on the swim & dive page online.

- All qualifying meets must use Hy-tek meet manager to run the meet and to provide meet results to the AIA.
- The **state qualifying dive meet** will be held Friday, October 21st for Division I and Saturday, October 22nd for Division II. Any diver meeting a provisional standard will qualify to participate in this meet. **This is the meet that will determine the 32 divers that will dive at the state meet.** There was discussion on the concerns from dive coaches about having a dive qualifying meet and the date of that meet. The original choice was the Wed/Thur. of the last weekend of the season, however, those were AIMS testing days. The last weekend of the season was reserved for city meets, last-chance meets, region meets, etc. The committee was asked to discuss with dive coaches options in the future.
- **State Swim & Dive Championships** will be held November 4th & 5th, 2011 at Skyline Aquatic Center on the campus of Skyline High School. Division I will prelim during the a.m. session on Friday and Division II will prelim during the p.m. session on Friday. Saturday finals will be run with 2 pools starting at 12:00 noon for swimming. The schedule and timeline can be found in the tournament guide that will be located on the swim & dive page of AIA365 within the week.
- **State Performance lists** will be posted every Tuesday (tentatively) on the swim & dive page. This will be done electronically with results from qualifying meets.

From the group:

- Rich McClure expressed some concern with using Hy-tek team manager lite when entering into the state meet. The entry method for the state meet has not been finalized yet, but we will consider those concerns.
- Brian Anderson asked if the performance lists after each meet will be posted. Yes they will and the coaches will not have to submit their athletes that meet provisional or automatic standards.
