## NATUROPATHIC DOCTORS - Christine Girard, ND

- ➤ The SMAC listened to Dr. Girard's presentation in regards to Naturopathic Doctors.
  - The committee will listen to a chiropractor at the next SMAC meeting.
  - The committee will then vote at the following SMAC meeting as to whether or not Naturopathic and Chiropractic physicians can assess the pre-participation physicals and concussion assessments on student athletes.

# <u>UNIFIED SPORTS – Scott Brown</u>

- Scott Brown presented pre-participation forms that are used by Special Olympics Arizona for the SMAC to compare with the current pre-participation forms used to see what adjustments need to be made for Unified Sports.
- > Special Olympics Arizona requested for the Unified Sports participants to have a physical every year.
- > After discussion, it was recommended to use the SOAZ form for Unified Sports separately.
- > Dr. Cardenas will revise the Special Olympics form for the next meeting.
  - Add a section on the first page to clarify what sport they are participating in.
  - Current Special Olympics physicals will be grandfathered in.

## **HEAT EXHAUSTION - David Hayward**

- David Hayward discussed the current 7:00 p.m. start time for high school football games and said that this current time would be sufficient due to the drop in temperature by that time.
- > Cross Country has issues due to the time of the meets.
- ➤ The committee will provide a Heat Index Chart for protocol based on the health of the athlete and standard of care.
- The committee discussed possible restrictions if it's found that it is not okay to play, for example, practicing without pads or after a certain time frame.
- Data would be retrieved from across the state from approx. (10) different devices.
- Recommended to have 14-15 days for acclimatization.
- ➤ The SMAC will have the proposal for the next meeting.

## BRAINBOOK - Dr. Cardenas

- ➤ There have been over 25,000 who have completed the Brainbook Concussion Course to date.
- ➤ The Brainbook release was covered by media in (30) states and (11) countries.
- ➤ The Deer Valley Unified School District will be using Brainbook for their middle school education.

  - Gary Whelchel will ask the AIA Football Sports Advisory Committee to work on the wording and forward it to the SMAC.
- ➤ The helmet rule will be assessed for one year in Arizona, collect data and forward the information to the NFHS to make a rule change in the football rules books for the 2012-13 school year.
