FOOTBALL SPORTS ADVISORYCOMMITTEE -

PROPOSED AMENDMENT TO FOOTBALL BYLAW – EMERGENCY LEGISLATION

Dana Zupke, representing the Football Sports Advisory Committee, addressed the Board with the proposed bylaw amendment listed below. Discussed at length was the permissive practice bylaw and the definition of non-contact conditioning. Safety concerns were addressed by the Board. Dr. Steven Erickson, representing the AIA Sports Medicine Advisory Committee joined Mr. Zupke for

further conversation with the Board.

Rationale for Proposed Amendment:

To align with spring practice bylaw 23.10.1, which already allows for the use of shields and dummies during spring practice when no protective equipment is worn. It is the belief that the ability to use shields and dummies increases the safety to the student athlete by teaching contact techniques in a controlled, safe progression prior to full contact practice.

23.3 PRE-COMPETITION PRACTICE

23.3.1 Permissive - Permissive practice on Monday, Tuesday and Wednesday shall be conducted without pads and limited to non-contact conditioning. Permissive practice on Thursday, Friday and Saturday will allow the addition of shoulder pads, blocking dummies and blocking sleds.

23.3.1.1 Monday, Tuesday and Wednesday no coaching/instructional football equipment shall be used for on-the-field practice. However, coaches may use whistles, stopwatches,

clipboards, megaphones and air horns, and players may use whistles, stopwatches

mouthpieces. The use of footballs, kicking tee, ropes, tires and pylons are permitted.

The use of shields and dummies during this time is permissible.

23.3.1.2 Thursday, Friday and Saturday the coaching/instructional football equipment of

shoulder pads, blocking dummies and blocking sleds are permitted.

23.10 SPRING FOOTBALL INSTRUCTION

23.10.1 A coach may instruct candidates for the high school's football squad for three consecutive weeks,

commencing on the 44th week of the AIA standardized calendar and concluding in the 46th week.

11/17/11

HEAT EXHAUSTION POLICY PROPOSAL – John Parsons and David Hayward John Parsons reviewed the proposal handout with the committee.

David Hayward discussed the fact that 90% of heat related deaths happen within the first five days. Heat acclimatization is most important.

Reporting system for acclimatization within the first 14 days.

Four components were reviewed:

- Heat Acclimatization approved
- Environmental Assessment disapproved (Will continue to work on the Environmental Assessment part)
- Hydration approved
- Return to Play approved

Arizona Interscholastic Association Sports Medicine Advisory Committee presented proposed Heat Acclimatization & Exertional Heat Illness Management Policy Recommendation to the committee members

1/26/12

SB 1035 (Heat Index) – (John Parsons) The committee reviewed the proposed Heat Index bill. If a heat index is used properly it can be expensive (equipment and training).

Heat Index scale is not designed for Arizona.

Acclimatization is key part.

The first 3-5 days of practice is when most deaths occur.

Last year a change was made to the football schedule based on the heat advisories.

Mark Mignella requested that a representative speak on behalf of the SMAC on SB1035.

HEAT POLICY UPDATE:

Reviewed policy and made revisions. Arizona Interscholastic Association Sports Medicine Advisory Committee presented proposed Heat Acclimatization Policy to the AIA Executive Board

Mark Mignella discussed the proposal. He explained that conference level committees were informed at each of their meetings regarding potential state legislation regarding heat restrictions and school sport activity. The topic inclusion within the scope of discussion and concern by the Sports Medicine Advisory Committee was also shared with the region representatives at all conference level meetings.

c. Discuss AIA bylaw; article 23.10.1-Spring Football Instruction (equipment allowed)

The following AIA Bylaws related to this agenda item were distributed.

23.9 OUT-OF-SEASON FOOTBALL ACTIVITIES

23.9.1 Out-of-season football activities are permitted from the 47th week to the first day of permissive practice. During this time a coach may give football instructions to any member of his football squad.23.9.2 Instructions are limited to non-contact activities and weight training. The only school equipment which may be used out-of-season is footballs, kicking tees and football shoes.

23.9.3 School Transportation During Summer - School provided transportation for summer activities is a local option.

23.9.4 With school district governing board approval, weight training or other activities may be conducted in school athletic facilities.

23.9.5 Attendance at summer activities shall be voluntary and no student athlete shall be prohibited from participating on athletic teams for failing to attend the summer activities.

23.9.6 Self-compliance, under the responsibility of the school principal, must be practiced.

23.10 SPRING FOOTBALL INSTRUCTION

23.10.1 A coach may instruct candidates for the high school's football squad for three consecutive weeks, commencing on the 44th week of the AIA standardized calendar and concluding in the 46th week. The use of shields and dummies during this time is permissible.
