Minutes of Oct. 16, 2013; Motion by Bob Wolf to approve, seconded by Bryan Smith, voted (5-0) and approved

Minutes of Emergency phone meeting on Feb. 11, 2014; Motion by Bryan Smith to approve, seconded by Rocky Nelson, voted (5-0) and approved

- Presentation from X Guard 360 by Allen Crick on mat cleanliness and their product
- Sectional Tournament locations and format: Colorado model vs. California model; lots of discussion; Motion by Bryan Smith to bring forth the Colorado method for criteria as to how schools will qualify for state tournament to the schools for survey and input, seconded by Rocky Nelson; motion passed (5-0). Bob C. needs to put get info to Dean to out by next week to the schools and have results by April 4.
- Seeding Criteria for Sectionals and State: Motion by Bryan Smith that in order for a wrestler to be seeded, he/she must have a minimum 7 matches overall to be seeded, seconded by Rocky Nelson, motion passed (4-1) Committee asked for an appeal process for seeding criteria
- Chuck Schmidt informed committee and guests the procedures followed by the AIA on the cancelation and postponement of the Sectional tournament in February.
- Inputting of regular season records Track vs. NWCA: coaches not inputting wrestling results on Track Wrestling in a timely manner, coaches inputting and changing wrestlers records. Record differences between Track wrestling and NWCA, there is no cross checking. What can be done to get them together with information? Need to resolve



before October. Generate check dates for upcoming season with consequences for not inputting in a timely manner.

- NWCA AZ State Exceptions: Dean will work on Q&A for state wrestling guide.

Discussion Items:

- State Tournament – Warm up time – AIA 365:
 - State Tournament – same section wrestlers wrestling each other in the first two rounds. Is there a way to have them separated? Number ones and Two are separated and the rest are randomly drawn. Div. I & II should be wrestling on Thurs/Fri for the upcoming season.
 - Warm up time – 15 minutes for Div. I & II
 - AIA 365 – no wrestling results, rankings, or any information pertaining to wrestling; no media coverage in newspapers
- Scheduling of regular season matches: more frosh and JV tournaments on Saturdays
- Skin issues and weigh-ins – regular season and post season: Who is checking for skin issues?
- Weight certification Appeal By-Law : passed by Legislative Council at last meeting in March
- Match Payment / Referees: passed by legislative council = \$63 per match (dual) after that it is \$4.50 per match in a dual, need an option for AD to post # of matches in dual in order to change the pay rate.
