EXECUTIVE DIRECTOR REPORT

A trophy presentation schedule was presented to the Board for the 2014 Fall State Tournaments.

Dr. Tricia Pena, representing FINAO, delivered a presentation to the Executive Board regarding FINAO - "Failure is not an option". She explained that the program is good for kids and that MILO is the platform behind FINAO. Dr. Slemmer noted that the program will also be discussed at the upcoming Section 7-8 meeting.

Dr. Slemmer noted that after the Fall Hardship Appeals, additional alternate committee names will be needed from the 1A-4A conferences due to current committee members being unable to attend or having to leave the hearings early.

Mr. Schmidt updated the Board on rule books. He noted that that the electronic versions of the books, which are purchased from the NFHS and downloaded on phones or tablets, are **not** printable. In October, AIA staff will present the Board with a proposal outlining and identifying the price point of the AIA to continue the service of distributing rule books out of the AIA office.

The Board was updated on Robotics and given specifics of the upcoming pilot program. On a motion duly made, seconded and unanimously carried, the Board **approved** May 23, 2015 as the date for the AIA Robotics State Tournament, which will be held at Tim's Toyota Center.

Mr. Schmidt shared information with the Board regarding a recent grant received based on the support from Barrows Institute & Dr. Cardenas (SMAC). The grant will assist schools, who in the past were unable to provide qualified medical professionals at their regular season events. A process will be implemented and schools will be able to apply to the AIA office for grant money for assistance. The Board thanked Mr. Schmidt for obtaining the grant and for helping small and rural schools.

The Board was provided with an incident report from a baseball umpire regarding Veritas Prep and a baseball game played last spring. President Wilson indicated that their decision made last month was based on the presentation made by Veritas Prep. The Board will not change their decision, but requested that Dr. Slemmer contact Veritas Prep and further discuss the incident.

Open Discussion – Current Issues

President Wilson discussed the AIA Bylaws and the possibility of governance restructure of the current bylaw book. In October, the Board will discuss forming a sub committee to review the current AIA Bylaws and will submit their feedback to staff regarding possible changes.

AIAAA – Sr. Lynn reported on the recent AIAAA meeting held in Prescott. She noted that the conference was a success and that the speakers got great reviews. Sr. Lynn thanked Dr. Slemmer and AIA Staff for their involvement and Mr. Schmidt for obtaining sponsorships and their funding.

Mr. Schmidt noted that at the October meeting, the Board will be presented with a trophy presentation schedule for Activities for the 2014-2015 school year.

Dr. Slemmer shared with the Board that dates have been established for upcoming roundtable discussions with the district athletic directors – September 25th and November 6th. Additional dates to follow.

On a motion duly made, seconded and unanimously carried, the Board **approved**, contingent on concurrence from the SMAC Committee, the following bylaw amendment (Emergency Legislation)

Soccer - Season of Sport - Contact Rule/Concussions/Heading Training

Proposed Amendment -

Due to the severity of concussions and both number of concussions in soccer and the long-term consequences of concussions the following amendment is being proposed.

25.2 SEASON OF SPORT

- 25.2.4 <u>Pre-Competition Practice</u> Practice shall be conducted in a manner consistent with the guidelines set forth in Bylaw 14.17.2 Heat Acclimatization Protocol, where applicable.
- 25.2.5 Contact Rule/ Heading Training Definition of Contact/Heading Training Specific activities wherein the student-athlete(s) actively heads the ball consistently as a manner of technical training. Contact/Heading during the course of simulated match activities does not constitute specific heading training. (i.e. heading a ball from a cross, heading a punted ball during a simulated game, etc.)

<u>Pre-season</u> – During the preseason, no more than 15 minutes of practice time each day with no more than two training sessions each week may include specific heading activities.

<u>Regular Season</u> – During the regular season, no more than 15 minutes of practice time each day and no more than 2 practices each week may include specific heading activities.

PHOENIX CHRISTIAN - REQUEST - EXCEPTION TO AIA BYLAW 23.5.3.1

Rule: Article 23. Football, Section 23.5 Number of Games in Season

23.5.3.1 <u>EXCEPTION</u>: Division IV, <u>V & VI</u> schools, because of their limited enrollment, may permit a player to participate in 50% more matches or games than the regularly scheduled matches or games per season, excluding qualifying and post-season

<u>Example</u>: If a school scheduled 20 games or matches, each player could participate in 50% more games or matches for a total of 30. (Emergency Legislation 8/18/14)

Phoenix Christian is playing in Division III which is up two levels for enrollment. Phoenix Christian would like to use the exception that Division IV, V, VI schools use – PC is in Division V in school size.

On a motion duly made, seconded and unanimously carried, the Board <u>denied</u>, Phoenix Christian's request for an exception to AIA Bylaw 23.5.3.1.

ESTRELLA FOOTHILLS – REQUEST – EXCEPTION TO AIA BYLAW 30.5.3

- Rule: Article 30. Volleyball, Section 30.5 Number of Games in Season
- 30.5.1 No school shall schedule more than 20 varsity matches, including three invitationals which shall count as one match each.
- 30.5.2 No school shall schedule more than 19 junior varsity or 19 freshman matches per team.
- 30.5.3 No player shall participate in more than 20 matches per season, excluding post-season tournaments six (6) sets/night (for regular season matches only).
 - 30.5.3.1 EXCEPTION: Division IV/V schools, because of their limited enrollment, may permit a player to participate in <u>8 sets/night (for regular season matches only)</u>. an unlimited number of matches during the season of sport.
 - 30.5.3.2 <u>EXCEPTION</u>: Division III schools, because of their limited enrollment, may permit a player to participate in 50% more matches or games than the regularly scheduled matches or games per season, excluding qualifying and post-season tournaments.

<u>Example</u>: If a school scheduled 20 games or matches, each player could participate in 50% more games or matches for a total of 30.

On 5/19/14, the Executive Board, in accordance with Article 16, Section 16.1 of the AIA Bylaws, placed the Betty H. Fairfax High School **Softball Program** on **Probation** for one year for a reported violation of *Article 26. Softball, Section 26.1 Rules* of the AIA Bylaws.

In accordance with the due process provisions of Article 16, Section 16.4, Paragraph 16.4.5 of the AIA Bylaws, Betty Fairfax High School submitted an appeal for reconsideration of the Probation sanction against the Softball Program.

Following reconsideration, the Executive Board instead placed the Betty Fairfax High School **Softball Program** on **Warning** for one year – 5/19/14-5/19/15.

PIMA HIGH SCHOOL

The following representative entered the meeting for a school report and left upon completion of his presentation:

On 5/19/14, the Executive Board, in accordance with Article 16, Section 16.1 of the AIA Bylaws, placed the Pima High School **Baseball Program** on **Probation** for one year for a reported violation of *Article 20. Baseball, Section 20.1 Rules* of the AIA Bylaws.

In accordance with the due process provisions of Article 16, Section 16.4, Paragraph 16.4.5 of the AIA Bylaws, Pima High School submitted an appeal for reconsideration of the Probation sanction against the Baseball Program.

Following reconsideration, the Executive Board instead placed the Pima High School **Baseball Program** on **Warning** for one year – 5/19/14-5/19/15.

SCHOOL VIOLATIONS

The following representative entered the meeting for a school report and left upon completion of his presentation:

BOWIE-SAN SIMON HIGH SCHOOL reported a violation of the AIA Bylaws; namely, *Article 20. Baseball, Section 20.1 Rules*

Reported Violation:

On April 1, 2014, Pima hosted Bowie-San Simon in a varsity baseball game, the game was also a Section game. After the completion of 1 ½ innings, the score of the game was 29-2 in Pima's favor. The head coaches from both teams discussed Bowie-San Simon forfeiting the contest during the 1st inning and discussed the situation with the game officials. The coaches were informed of the 15 run rule after 3 ½ innings by the game officials at that time. At the completion of the visitors half of the 2nd, Bowie-San Simon conceded the game to Pima. Both teams agreed that it was a forfeit and left the field of play.

School's Corrective Action:

The new A.D. has in-serviced the baseball coach on the rules pertaining to the completion of a varsity contest. Further disciplinary action against the coach will be handled internally at the school. At the beginning of the 2014-15 school year, all Bowie-San Simon coaches will be inserviced on AIA rules prior to the beginning of the school year. This in-service must be attended by all coaches prior to start of each school year from here on out before they can coach that school year.

Executive Board Action:

Executive Board, in accordance with Article 16, Section 16.1 of the AIA Bylaws, placed the Bowie-San Simon High School **Baseball Program** on **Warning** for one year 9/10/14-9/10/15.

<u>CANYON DEL ORO HIGH SCHOOL</u> reported a violation of the AIA Bylaws; namely, <u>Article 14. General Provisions, Section 14.14 Concussion Education</u>

Reported Violation:

Football coach permitted a student to participate in practice prior to student completing Brainbook. The coach believed he had received a "yellow slip" clearance for the student. He placed the student's name on his roster. The error was discovered when the coach cross checked his roster in preparing for contact. The student participated in conditioning only – no contact.

School's Corrective Action:

The coach has received a letter of reprimand for not properly following District and school procedures. He has been an assistant football coach for 18 years and has not had any previous infractions or disciplinary issues. The school clearance procedure was changed by eliminating the "yellow clearance slip" to coaches. A roster of cleared players is produced by the athletic department and only students listed on the roster will be permitted to participate. The yellow slip clearance had been in place to permit students who were cleared late in the day to participate that day.

Executive Board Action:

Executive Board, in accordance with Article 16, Section 16.1 of the AIA Bylaws, placed the Canyon del Oro High School **Football Program** on **Advisement** for one year 9/10/14-9/10/15.

Joe Paddock abstained from voting.

<u>SAN MIGUEL HIGH SCHOOL</u> reported a violation of the AIA Bylaws; namely, <u>Article 15. General Provisions, Section 15.7 Physical Exam Rule & 15.8 Parental or Legal Guardian Consent</u> Rule

Reported Violation:

Two ineligible boys' soccer players. Students were not cleared to participate. One player was injured during practice when he collided with another player. Before the team departed campus for practice, the head coach had checked players off to ride the bus and gave the list to her assistant coach. The assistant coach was left with the clearance roster and allowed the two non-cleared players to participate. The head coach stayed behind to help another potential player complete Brainbook The head coach arrived later to practice after the player had been injured. (See report for details regarding the incident)

School's Corrective Action:

Internal policies have been reviewed. Clearance policy in place. Those involved in this case were held accountable and have been relieved of their duties. Students are not allowed to participate in any fall programs and may extend that ban for the remainder of the school year.

Executive Board Action:

Executive Board, in accordance with Article 16, Section 16.1 of the AIA Bylaws, placed the San Miguel High School **Boys' Soccer Program** on **Warning** for one year 9/10/14-9/10/15.

KINGMAN HIGH SCHOOL reported a violation of the AIA Bylaws; namely,

Article 15. General Provisions, Section 15.7 Physical Exam Rule & 15.8 Parental or Legal Guardian Consent Rule

Reported Violation:

Ineligible football players. A new head football coach was hired less than a month ago. Kingman HS has gone over the rules required in order for a student to participate in high school athletics. The same would be true of his assistant coaches. Two JV players received gear to practice without receiving the proper clearance from the athletic office. When double-checking the roster between his records and our records, the mistake was noted and those two players were immediately removed from the field.

School's Corrective Action:

The AD and the head coach will go through additional training on the rules as they pertain to this situation and involve the assistant coaches. The head coach will also begin taking roll call at the beginning of each practice with a current list provided by the athletic office so they are aware of who is at practice and who is cleared to practice. Kingman apologizes for the mistake.

Executive Board Action:

Executive Board, in accordance with Article 16, Section 16.1 of the AIA Bylaws, placed the Kingman High School **Football Program** on **Warning** for one year 9/10/14-9/10/15.

PARADISE HONORS HIGH SCHOOL reported a violation of the AIA Bylaws; namely,

Article 15. General Provisions, Section 15.7 Physical Exam Rule & 15.8 Parental or Legal Guardian Consent Rule

Reported Violation:

Ineligible JV football player. Student was practicing (3 days) with the football team without any paperwork being turned in.

School's Corrective Action:

Head football coach has been suspended for the 1st game. We now have a system to where once a student turns in their completed athletic packet, they are issued a purple clearance card that needs to be handed to the coach in order to participate and practice.

Executive Board Action:

Executive Board, in accordance with Article 16, Section 16.1 of the AIA Bylaws, placed the Paradise Honors High School **Football Program** on **Warning** for one year 9/10/14-9/10/15.

LEE WILLIAMS HIGH SCHOOL reported a violation of the AIA Bylaws; namely,

<u>Article 15. General Provisions, Section 15.7 Physical Exam Rule & 15.8 Parental or Legal Guardian Consent</u> Rule

Reported Violation:

Ineligible football player. It was discovered a student athlete began practice on August 12th without turning in his proper paperwork into the athletic office. He had his physical and emergency consent form completed and signed, but just showed the coaches the forms. All forms must be turned into the athletic office prior to clearance for practice.

School's Corrective Action:

Meeting held with head coach. Attendance will be taken the first 10 days of practice in each season. Head coaches will collect clearance cards, and provide in writing to the athletic office the procedures discussed with assistant coaches for collecting clearance cards. Rosters will be updated daily. Any student present without a clearance card and NOT on the roster provided by the athletic office will NOT be allowed in the practice area, i.e. field, court, track, etc.

Executive Board Action:

Executive Board, in accordance with Article 16, Section 16.1 of the AIA Bylaws, placed the Lee Williams High School **Football Program** on **Warning** for one year 9/10/14-9/10/15.

SAN LUIS HIGH SCHOOL reported a violation of the AIA Bylaws; namely,

Article 15. General Provisions, Section 15.7 Physical Exam Rule & 15.8 Parental or Legal Guardian Consent Rule

Reported Violation:

Ineligible swimmers. Swim coach did not follow clearance procedures and allowed approximately 10 students to practice for 3 days without being cleared. Coach interpreted being told she could wait and take impact testing as a team as being able to skip the clearance process. Coach admits this, but does not have exact list of the ineligible students.

School's Corrective Action:

While investigating, assistant coach has taken over and been given specific instructions on clearance and told to bring all questions to the AD. AD will address issue with team directly at meeting. As a first year AD, I am following procedures and quickly addressing the issue. As per previous violation, coach may be removed immediately or non-renewed.

Executive Board Action:

Executive Board, in accordance with Article 16, Section 16.1 of the AIA Bylaws, placed the San Luis High School **Swim Program** on **Probation** for one year 9/10/14-9/10/15.

<u>TOMBSTONE HIGH SCHOOL</u> reported a violation of the AIA Bylaws; namely, <u>Article 15. General Provisions, Section 15.3 Enrollment Rule</u>

Reported Violation:

Ineligible football players. AD asked student's mom for the certificate from the county in which she registered her sons to be home schooled. She told AD they were not being home schooled this year and they were attending the Berean Academy in Sierra Vista. Last year students were home schooled and played football for Tombstone. Once this situation was discovered, both boys were immediately removed from the practice field and were told that they could not practice or play any sports at Tombstone High School while they were attending another school.

School's Corrective Action:

From this point forward, no home schooled student will be allowed to practice or play in any games until a certificate from the county, which states the student is registered to be home schooled, is received by the AD.

Executive Board Action:

Executive Board, in accordance with Article 16, Section 16.1 of the AIA Bylaws, placed the Tombstone High School **Activities Program** on **Advisement** for one year 9/10/14-9/10/15.

<u>TOLLESON HIGH SCHOOL</u> reported a violation of the AIA Bylaws; namely, <u>Article 17. Coaches & Coaching, Section 17.5 Open Facilities</u>

Reported Violation:

Girls' volleyball coaches held a non-paid volleyball camp from 8/8/14 - 8/8/14 where direct skill instruction was given, along with evaluation of specific skills.

School's Corrective Action:
