SANTA RITA HIGH SCHOOL reported a violation of the AIA Bylaws; namely, *Article 15. General Provisions*, Section, 15.10 Transfer Rule

Reported Violation:

Two (2) ineligible football players. Transfer students.

1st student – While the 520 form was completed, a 530 form should have been completed because it would have indicated that the student played at Santa Rita last year. A formal hardship appeal should also have been completed to make the student eligible. The student was enrolled at Santa Rita as a freshman and withdrew his sophomore year. He re-enrolled at Santa Rita as a junior. He left Santa Rita to attend a charter school to complete credit recovery. The charter school he enrolled at did not have an athletic program, so he did not play football and was not flagged on his 520 form. 2nd student – Student withdrew his sophomore year. He was enrolled at Santa and withdrew for safety reasons. With a new administration Mom felt that the campus was safe again and wanted her son to return to his home school. Student re-enrolled.

School's Corrective Action:

Contests forfeited. Will have specific professional development for all administrators on campus to understand the forms as they relate to student eligibility. This same professional development will be given to all coaches. Coaches will be required to collect all paperwork from players and verify eligibility. New clearance process in place. See report for details.

Executive Board Action:

Executive Board, in accordance with Article 16, Section 16.1 of the AIA Bylaws, placed the Santa Rita High School **Activities Program** on <u>Warning</u> for one year 10/29/14-10/29/15 and due to lack of a motion, <u>denied</u> rescinding the forfeitures.

Vice-President Mike DeLaO conducted meeting in Doug Wilson's absence.

REQUEST FOR RECONSIDERATION OF DISCIPLINARY ACTION

MOUNTAIN VIEW MARANA HIGH SCHOOL

On 10/21/14, the Executive Board, in accordance with Article 16, Section 16.1 of the AIA Bylaws, placed the Mountain View Marana High School **Football Program** on <u>Probation</u> for one year for a reported violation of <u>Article 15. General Provisions, Section 15.12 Recruitment Rule</u> of the AIA Bylaws.

In accordance with the due process provisions of Article 16, Section 16.4, Paragraph 16.4.5 of the AIA Bylaws, Mountain View High School submitted an appeal for reconsideration of the Probation sanction against the Football Program.

Updated Corrective Action:

Mountain View High School will provide Head Coach a letter of discipline regarding recruitment. He will also serve a one game suspension during the current 2014 football season.

Executive Board Action:

Due to a lack of a motion, the appeal was <u>denied</u>. The Football Program will remain on <u>Probation</u> for one year 10/20/14-10/20/15.
