- State Tournaments

Division I at Aguila. Girls Nov. 2<sup>nd</sup> & 3<sup>rd</sup>. Boys 4<sup>th</sup> & 5<sup>th</sup>.

Division II in Tucson, dates and courses TBD. Suggested: Randolph and Del Ulrich.

- a. Last date for qualifying changed to Oct. 26<sup>th</sup> (which is the last date to practice on state course)

## Action Items:

- State Qualifying

Div. I B & G: 5 Section Champions, 10 at large bids based on IWanamaker. Top 15 individuals - 90 total players.

Div. II B & G: 9 Section Champions, 6 at large bids based on IWanamaker. Top 21 individuals – 96 total players.

IWanamaker Team rating based on top 7 team scores not on top 4 individual averages on the season. Maximum of four scores from any one course.

- IWanamaker
  1. Home team must input schedule into Iwanamaker
  2. System worked well. Looking for sponsors to cover expenses rather than charge teams.
- Div. III to recognize female medalist with medal (with pink ribbon!).
- Recognition of each section top individual golfers with certificates.

- Girls on Boys (Co-Ed) Teams in Div. I and II: (motion and approval pending discussion at the next meeting)

Starting in the 2016-17 school year, girls playing on boys (Co-Ed) teams must declare prior to the first date of competition if they will play as part of the boys team or as an individual attempting to qualify for the Girls State Championship. If she declares to play as a member of the team, she will play from the same set of tees as the boys (with the men's slope and rating). If she declares for attempting to qualify as an individual for the girls tournament, she can play from any set of tees (with the woman's slope and rating), but her score will not count towards team score.
