# TRAVEL AND EXCHANGE PROGRAMS - Cont'd

#### **Listing Types**

These categories were designed by the CSIET Board of Directors to encourage organizations to administer their programs according to the highest possible standards and to permit the Evaluation Committee to accurately and fairly reflect its conclusions.

**Full Listing** is the status that organizations and programs described in the CSIET Advisory List are accorded when they have demonstrated full compliance with the CSIET Standards.

**Provisional Listing** reflects the Evaluation Committee's determination that an organization, during its first or second evaluation, is judged to be in compliance with CSIET standards on the basis of its application materials. Provisional Listing will be granted to a newly accepted organization for two one-year periods, provided experience with the organization during this time affirms the Committee's assessment. After one year, Provisional Listing may be renewed for a second year. Or, if there is inadequate compliance with specific standards, the organization may be denied listing.

**Conditional Listing** is a status that may be granted to an organization that had previously achieved either a Full or Conditional Listing. It is issued to organizations that the Accreditation Committee determines are substantially in compliance with the standards but which need improvement in one or more areas. Conditional Listing is granted for one year, but may be renewed for subsequent one-year periods upon completion of review by the Accreditation Committee

# **SCHOOL VIOLATIONS**

HORIZON HONORS HIGH SCHOOL reports a violation of the AIA Bylaws; namely,

Article 15. Student Eligibility Rules, Section 15.3 Enrollment Rule

# **Reported Violation:**

The student is a home schooled student who lives in Casa Grande (Pinal Country). He has played basketball and baseball for us. Our school is in Maricopa County, as a result he is not eligible to play sports at Horizon Honors in reference to the above bylaw that states a home schooled student must participate at the school within their attendance zone.

#### **School's Corrective Action:**

Athletic Department will verify that all home schooled students participating reside in Maricopa County.

#### **Executive Board Action:**

Executive Board, in accordance with Article 16, Section 16.1 of the AIA Bylaws, placed the Horizon Honors High School **Activities Program** on **Warning** for one year 8/17/15-8/17/16

**CAMP VERDE HIGH SCHOOL** reports a violation of the AIA Bylaws; namely,

Article 15. Student Eligibility Rules, Section 15.3 Enrollment Rule

#### **Reported Violation:**

A student who is currently enrolled in a local charter school participated in one day of Spring Football practice. The head coach checked with the front office and was told that the student had pre-enrolled for fall 2015. He allowed the student to participate.

# **School's Corrective Action:**

We in-serviced the coach on the use of non-member students as it relates to Spring football practice.

#### **Executive Board Action:**

Executive Board, in accordance with Article 16, Section 16.1 of the AIA Bylaws, placed the Camp Verde High School **Activities Program** on **Warning** for one year 8/17/15-8/17/16

#### **SCHOOL VIOLATIONS** – Cont'd

**SUNNYSIDE HIGH SCHOOL** reported a violation of the AIA Bylaws; namely *Article 15. Student Eligibility Rules*, Section 15.5 Domicile Rules

#### **Reported Violation:**

While living in another school's attendance zone, the student wrestled for Sunnyside. This was discovered on April 21, 2015 when the student was found in possession of illegal drugs on campus. It was also discovered that his parents submitted two false documents to the school's registrar: 1. false lease agreement. 2. False AZ driver's license.

This revealed that the student's domicile was not in the attendance zone of Sunnyside High School as had been filed with the Sunnyside registrar's office in November 2014. The student had transferred from Ironwood Ridge High School and enrolled at Sunnyside on 11/13/2014, thus a 520 form was made and submitted. He began competition for Sunnyside after January 1, 2015. Student was withdrawn from Sunnyside on April 9, 2015 after the incident with illegal drugs on campus and indicated he will return to Sunnyside for the 2015-2016 school year due to the eligibility he has left according to the AIA bylaw; Article 15.9.

# **School's Corrective Action:**

Contests forfeited. The AD will review AIA Bylaws with all coaches prior to start of school year. The registrar will give copies of paperwork to AD and the AD will administer home visit to verify domicile listed with school files.

#### **Executive Board Action:**

Executive Board, in accordance with Article 16, Section 16.1 of the AIA Bylaws, placed the Sunnyside High School **Activities Program** on **Advisement** for one year 8/17/15-8/17/16

Sunnyside will appeal the forfeitures to the board at the September meeting so they can bring any further information forward.

# SCHOOL VIOLATIONS - Cont'd

<u>CACTUS SHADOWS HIGH SCHOOL</u> reported a violation of the AIA Bylaws; namely, Article 15. Student Eligibility Rules, Section 15.10 Transfer Rule

#### **Reported Violation:**

Transfer student from an associate member school was allowed to participate in JV volleyball. Since no games against member schools were played by the student at her former school, we felt the transfer was appropriate and thus the student was eligible. The transfer was made without a change of domicile.

# **School's Corrective Action:**

Extensive rules/bylaw clarification with Mr. Halbach. Specific reference to and search for non-member schools now implemented in clearance process. Principal, Assistant and Coaches will be taught procedure.

#### **Executive Board Action:**

Executive Board, in accordance with Article 16, Section 16.1 of the AIA Bylaws, placed the Cactus Shadows High School **Activities Program** on **Advisement** for one year 8/17/15-8/17/16.

<u>BARRY GOLDWATER HIGH SCHOOL</u> reported a violation of the AIA Bylaws; namely, <u>Article 21. Basketball Rules, Section 21.9 School Equipment</u>

#### **Reported Violation:**

At a recent "club basketball" tournament, the women's basketball coach utilized school uniforms during the scheduled games. The head coach for the program contacted the equipment manager requesting the uniforms and he was provided with them.

# **School's Corrective Action:**

Coaching change within the program. Education and process clarification for equipment manager. Process for coaches getting equipment was modified and parties involved were notified.

#### **Executive Board Action:**

Executive Board, in accordance with Article 16, Section 16.1 of the AIA Bylaws, placed the Barry Goldwater High School **Girls Basketball Program** on **Advisement** for one year 8/17/15-8/17/16.

# **SCHOOL VIOLATIONS** – Cont'd

<u>HIGLEY HIGH SCHOOL</u> reports a violation of the AIA Bylaws; namely, Article 36. Spiritline Rules, Section 36.6 Season of Activity

#### **Reported Violation:**

The Higley High School Spiritline conducted a tryout on the first day of school (7/21/15). Our coach was in the habit of having tryouts on the first day of school but HHS went to a year around calendar this year so the first day of school did not coincide with the scheduled 1st legal practice date. As soon as I discovered the issues, I informed my Principal and we moved tryouts to the week of August 3rd.

# **School's Corrective Action:**

The AIA Timelines will be reinforced at all coaches meetings. We are reopening tryouts during the week of August 3<sup>rd</sup>.

#### **Executive Board Action:**

Executive Board, in accordance with Article 16, Section 16.1 of the AIA Bylaws, placed the Barry Goldwater High School **Spiritline Program** on **Advisement** for one year 8/17/15-8/17/16.
