TRAVEL AND EXCHANGE PROGRAMS

The Executive Board reaffirmed its determination of September 16, 1996 concerning Article 15, Section 15.15, Paragraph 15.15.1 of the AIA Bylaws, which states that the AIA member schools should recognize only the foreign exchange programs approved by the Council on Standards for International Educational Travel (CSIET) (www.csiet.org).

The Executive Board directed that, as a convenience for AIA member schools, these official minutes reflect the travel and exchange programs listed in the CSIET's **2017-2018** edition of **Advisory List** - http://aiaonline.org/files/15938/2017-2018-csiet-advisory-list.pdf

It shall be the responsibility of the local school administrator to ensure that all other eligibility requirements are met before a student participates in interscholastic activities.

REQUEST – GREAT HEARTS ACADEMIES – ACCREDITATION

Great Hearts Academies presented an alternative method for accreditations (AALE) that will be reviewed by the Executive Board on August 29th.

REQUEST – 4A CONFERENCE DOUBLE-ELIMINATION STATE BASEBALL/SOFTBALL

The 4A Conference is requesting the AIA Executive Board approve a 16 team double elimination state tournament that follows the same format as the 5A and 6A Conferences for the 2018 baseball and softball season.

Matt Belden, 4A Conference Chair, presented information to the Executive Board. A survey was conducted of 4A Baseball and Softball coaches using the google document for voting for all-conference recognition. OF the 34 coaches that responded, 32 were in favor of a double elimination tournament that follows the 5A and 6A conference format.

On a motion made, seconded, and unanimously carried, the Executive Board **approved** the above request from the 4A Conference.

<u>REQUEST – 2A METRO WEST REGION</u>

The 2A Metro West Region is requesting a region tiebreaker in Volleyball and Basketball would follow the stated guidelines of Bylaw 12.1.6 through number one (head to head in Region/Section Games). If there is still a tie for 1st place or 2nd and 3rd place in the region, we would like to have the tie broken through a competition between the two teams that are tied.

For the sports of Volleyball and Basketball, the 2A Metro West Region has designed the schedules to complete our regular season competitions within the published AIA timeline and left opportunity for a competition as mentioned within the AIA timeline.

SCHOOL VIOLATIONS

GLENDALE PREPARATORY ACADEMY – Great Hearts Academies

Rule: Article 21. Baseball, Section 21.1 Rules

Reported Violation:

With the score 18-1 heading into the bottom of the 4th, the Glendale Prep coach and the Tempe Prep coach agreed to end the game after Glendale Prep's at bat. Glendale Prep coach indicated to Tempe Prep that they were out of pitching and were going to end the game. No umpire, nor the Tempe Prep coach questioned the decision, and the game ended after the 4th inning ended.

Schools Corrective Action:

Athletic Director has met with the baseball coach to review bylaws. Athletic Director will review all sports bylaws with coaches during pre-season meetings and trainings.

LEE WILLIAMS HIGH SCHOOL – Kingman Unified School District

Rule: Article 17. Coaches and Coaching, Section 17.5 Open Facilities

Reported Violation:

A student from Kingman High participated in an open gym for basketball. This took place at Lee Williams. The head men's basketball coach from Lee Williams was in attendance but did not give instructions.

Schools Corrective Action:

A checklist has been added to the open gym. Coach had a counseling session and we read the rules together. He is now aware of the rules and wants to be compliant.

Executive Board, in accordance with Article 16, Section 16.1 of the AIA Bylaws, placed the Lee Williams High School **Boys Basketball Program** on **Advisement** for one year 8/21/17-8/21/18.

COCONINO HIGH SCHOOL – Flagstaff Unified School District

Rule: Article 14. General Provisions, Section 14.2 Practice

Reported Violation:

March 12th, March 19th, and May 7th we had an assistant baseball coach throwing batting practice to a few players. All three of these dates are Sundays.

Schools Corrective Action:

Coach is also a parent to a player on our team, he was throwing to him when other players showed up. Educated about Sunday activities and warned of possible suspension.
