New Business:

- 3A Conference and 3A Region Alignments
 - A discussion on this issue had us break off into Regions and discuss no crossover games, 1 crossover game or 2 crossover games. Also, is it for FB only or all sports.
 - Motion made by Shawn Cluff (Florence) and 2nd by Terry Lantz (Coolidge) Motion was that on Week 4 we will have a FB Only Crossover game vs. opponent similary level of completion and Week 5 we will have Crossover games for All sports and this crossover games will be a Region geographically close to your Region (Central vs. South vs. Metro East, East vs. North, and Metro West vs. West). The vote was Yea's = 27 to Na's = 3
- Qualifying for the State Tournament in 2018-2020 With 7 Regions, I suggest that we only have Region Champions automatically qualify for the State Tournament and have 9 at-large bids. Thoughts?
 - Motion made by Paul Demuth (Holbrook) and 2nd by Shawn Cluff (Florence) Motion was that for All Sports we will automatically qualify 7 Schools (Region Champions from each region) and have 9 at-large bids based on Power Rankings if only 16 Schools qualify for the State Tournament or 17 atlarge bids based on Power Rankings if 24 schools qualify for the State Tournament. The vote was Yea's = 30 to Na's = 0

- Motion made by Jacob Holiday (Monument Valley) and 2nd by Pete Jelovic (Chino Valley) Motion was that for FB Only the High Seed will host the 1st Round and 2nd Round of the State Playoffs, except that Region Champs will host a 1st Round game even if they are not the High Seed when scheduled against a non-Region Champ. Example: 2017 3A State Playoffs #13 Page HS would have hosted #4 Ben Franklin in the 1st Round of the State Playoffs because Page was the North Region Champion and Ben Franklin was the #2 seed out of the Central Region. The vote was Yea's = 20 to Na's = 10
- Football 6 Quarters (per week) vs. Count Games
 - Motion made by Brandon Larson (Coronado) and 2nd by Heather Osborn (Az. College Prep) Motion was that the 3A Conference will allow FB players to play 6 quarters per week during the season instead of counting game. The vote was Yea's = 28 to Na's = 2
- Volleyball 6 matches (per night) vs. Count Games
 - Motion made by Lonnie Tvrdy (Pusch Ridge Christian) and 2nd by Jay Campos (Sabino) Motion was that the 3A Conference will allow VB girls to play 6 sets per night during regular season matches instead of counting matches. The vote was Yea's = 30 to Na's = 0
