➤ **PIATE RETURN TO PLAY (Dr. Baca)**

- Dr. Baca presents the Tempe UHSD Student Athlete Opiate PowerPoint that is implemented in the Tempe District.
- There are many protocols & education on opiate evaluation/treatment, monitoring opiate use/abuse and intervention.
 - The protocol continues to evolve and changes are expected over time.
- Dr. Anna Battle informs the committee that Athletic Directors in the Tempe District are embracing the challenge and discuss opiate education with their coaches and athletic trainers.
- The SMAC committee will review these protocols for any necessary changes.

➤ **CROSS COUNTRY HEAT ACCLIMATIZATION EDUCATION (Haley Root)**

- Haley Root discusses research data on heat acclimatization for Cross Country athletes.
- The recommendation for the heat acclimatization should occur near water and have medical coverage (AT).
 - Other suggestions are for student athletes to run during the early mornings and evenings. Also refrain from sending students into neighborhoods.
- David Hayward and Haley Root will work on gathering data from other member school ATs.

- **LEGISLATIVE UPDATE (Javier Cardenas)**
 - Dr. Cardenas discusses Arizona House Bills on opiate concerns and education.
- **IMMUNIZATIONS - TAPI (Kim Owens)**
 - The Arizona Partnership for Immunization (TAPI) is represented by Kim Owens and speaks on the recommendations on immunization education.
 - TAPI has many projects in being proactive on immunization education.
 - TAPI partner with high school to discuss with senior students the “Vaccinate before you Graduate” education and lists.
 - Flyers have also ben distributed across Arizona high schools.
 - Arizona colleges are also providing flyers and info, included the college packets.
- **CONSENT TO TREAT UPDATE (David Hines)**
 - The AIA has created a proposal that will be presented at the March 2nd Legislative Council meeting. This proposal is to add an additional Article in the AIA ByLaws – Policies and Procedures.
 - Article 41 - Sports Medicine
 - Under this article is would discuss Concussion Education, Emergency Action Place, Heat Acclimatization etc.
 - A parental consent form would also be added to the article along with the AIA Physical forms. The consent form would be in place to protect member schools ATs (medical staff).
- **IAMA RESEARCH ON PURITY OF SUPPLEMENTS (Javier Cardenas)**
 - Dr. Cardenas discusses the “Chemical composition and labeling of substances marketed as selective androgen receptor modulators and sold via the internet” research from the Jama Network.
 - Some student athletes that intake supplements may or may not know the ingredients in the supplements.
 - The SMAC committee recommends to emphasis on the second bulletin on Article 14.13 – make a statement to educate on supplement use & add a references and/or research.
