- Discussion of Post-Season Qualifications (Added to agenda prior to approval at meeting)
  - O Post-Season Qualifications were voted on and decided by the 2A AD's present at the May meeting.
  - Several ideas were discussed at the February meeting. Committees were formed to decide on the best propositions and bring them to the body of AD's for discussion and vote in May.

- Football: region champs get automatic birth into 16-team state field. The remaining 10 spots are field by the next highest power ranked teams. The field of 16 is ranked 1-16 based on powerpoints. Region champs will host the first round game unless they match-up with another region champ with a higher seed.
- Volleyball and Basketball: 8 region champs get automatic bid into the 16 team state tournament. Regions can play region tourneys at their discretion. The 2<sup>nd</sup> place team from each region will be placed in to a state play-in game along with the next 8 highest power ranked teams. The seeding of the play-in games are based upon powerpoints. The winners of the play-in games become the other 8 state qualifiers. The field of 16 state teams will be seeded based on powerpoints.
- Baseball and Softball: The 8 region champs receive automatic births into the state tourney. The final 8 spots will be awarded to the next 8 highest power ranked teams. The 16-team field will be seeded based on powerpoints. Region champs will be the designated home team in the opening round unless they play another region champ of a higher seed.
- State Qualifications is open to discussion each season not part of the 2-year block. If we are unhappy with the qualifications, we can bring it forth for discussion at the February meeting of 2A AD's.
