# **2020 FALL SPORTS RETURN SURVEY**

Data from the Fall Sports Return survey was provided to the Executive Board with a majority of member schools planning to participate in fall athletics. The AIA Staff has met with various committees regarding start dates for fall athletics. The Sports Medicine Advisory Committee, the Crisis Management Committee, Sport Advisory Committees and the Football Reclassification committee recommended a phased-in return for fall sports. Going from lowest risk to highest risk sports beginning from August 17<sup>th</sup> through September 7<sup>th</sup>. The approval of this recommendation would also require the winter season to begin one week later.

The following are dates that practices may begin with the phased-in approach:

August 17<sup>th</sup> – Golf and Spiritline (tryouts may be held)

August 24th - Cross Country and Swim and Dive

August 31st – Badminton, Girls Volleyball, Fall Soccer and Freshman Tennis

September 7<sup>th</sup> – Football

On a motion made, seconded and carried the Executive Board <u>approved</u> the recommendations. For more specific dates please refer to the Quick Glance Calendar.

Discussion took place regarding tournaments for fall team sports. Most conferences have determined they will not host nor attend tournaments for the 2020 fall season. On a motion made, seconded and carried the Executive Board **approved** no tournaments will be held for the 2020 girls' volleyball and fall soccer seasons.

- Transfer Rule (15.10.1) is in effect
- Scheduling remains at the responsibility of each Conference
- Game Change Fees will be determined on a case by case bases
- AIA Athletics are currently under the "out of season" rules
