EXCEPTION – TEMPORARY TRANSFER INELIGIBILITY – FOOTBALL

On a motion made, seconded and carried the Executive Board made the following exception for the 2020 football season.

Considering the current pandemic and its impact on the 2020 football season, for purposes of the temporary transfer ineligibility for football under 15.10.1, that temporary ineligibility will be considered completed and satisfied as of the end of the fourth week of allowable competition, 10/24/2020. <u>This applies only to football</u> <u>and only to the current season</u>.

WINTER SPORTS MODIFICATIONS / WRESTLING RECOMMENDATIONS

With the support of the Sports Medicine Advisory Committee, the Winter Sports Modifications and Wrestling Recommendations were presented to the Executive Board.

On a motion made, seconded and carried the Executive Board <u>approved</u> the Winter Sports Modifications and Wrestling Recommendations. Member schools are required to follow the modifications.

Winter Sports Modifications and Wrestling Recommendations have been posted to the AIA website.

TOURNAMENT REVIEW

On a motion made, seconded and carried the Executive Board **<u>approved</u>** the below adjustments to the modifications regarding invitationals for the winter sports season.

The following modifications were made regarding invitationals for basketball and winter soccer:

- One invitational will be permitted with the following guidelines:
 - Any school hosting or participating in the invitational must be on winter break.
 - Invitationals may be multi-day however teams must remain at the same school/site/facility in which they start each day. Teams may change school/site/facility the next day.
 - No more than eight (8) schools permitted per school/site/facility.
 - Teams are only permitted to participate in one (1) contest per day.
 - All games must be played on non-adjacent courts/fields (Adjacent is defined as side by side).
 - No out of state schools are permitted

Wrestling will have no invitationals this season. Dual meets are permitted with the exception that if a program does not have a full team, a small multiple can be schedule. Wrestlers are only permitted to wrestle once per day.

There being no further business, and on a motion duly made, seconded and carried, the meeting adjourned at 12:36pm.
