# REQUEST - AMERICAN LEADERSHIP ACADEMY - SIERRA VISTA

Buddy Allen, District Athletic Director, American Leadership Academies, addressed the Board regarding the opening of a new school.

Based on the written and oral information provided, on a motion made, seconded, and carried the Executive Board **paused** the membership application process.

#### SCHOOL VIOLATIONS

<u>CATALINA HIGH SCHOOL</u> – Tucson Unified School District Rule: Article 14. General Provisions, Section 2 Practice (14.2.2)

## **Reported Violation:**

On December 1st 2023 this reporter (AD) was notified of a potential violation by the AP of Interscholastic @ CHS (Catalina HS). He reported that the violation involved a wrestling student-athlete who allegedly practiced with another member school RUHS (Rincon/University HS) during the season of sport (Winter). This reporter initiated an investigation that included (in-person) interviews with the following; 1. The named student-athlete enrolled at CHS; 2. The AD of the member school RUHS to which the alleged practice took place; and 3. The head wrestling coach of CHS. An additional investigation was completed by the AP of CHS that included the AP of RUHS. This reporter also communicated with the TUSD district AD and the asst. Executive Director of the AIA for bylaw clarification. Other investigations were completed by RUHS AD and AP. CHS Student-Athletic (Wrestler): The student reported that on about Nov. 28th his cousin, and ex-wrestler, who had apparently graduated from RUHS (22 - 23 SY), and was a coach/participant for the RUHS wrestling program was on the phone with the Head coach of RUHS wrestling program. According the CHS student the RUHS coach was impressed by his skills during a recent dual meet hosted by CHS (NOV 21st). During the phone conversation the RUHS coach/participant invited the CHS student to attend an upcoming RUHS practice to demonstrate, train, or explain how to execute "a single leg take-down technique in front of the entire team in the RUHS wrestling room. It was reported by the CHS student that no other CHS students were present at the practice. He added that, "the other (RUHS) kids/team gathered around and watched me do this single take-down leg move with another RUHS player." He noted that he was at the practice for approx. 90m. The CHS student indicated that the head coach of RUHS invited him to attend another practice during the upcoming winter break practice (Dec 23th - Jan 7th)

#### **Schools Corrective Action:**

This writer met with the CHS student-athlete and provided a written document of the AIA bylaw 14.2.2 and he will apologize to his team for missing practice to attend another schools practice, and being dishonest to his coach. Additional education regarding TUSD/AIA policies, procedures, and bylaws will be reiterated and further emphasized to all coaches and student-athletes at CHS during preseason meetings involving transfer protocols, non-participation, and other eligibility related information. This writer will seek translators as necessary to accommodate language/comprehension barriers during school/parent/team meetings.

The Executive Board, in accordance with Article 16, Section 1 of the AIA Bylaws, placed the Catalina High School **Boys' Wrestling Program** on **Warning** for one year 1/16/24-1/16/25.

# **DESERT MOUNTAIN HIGH SCHOOL** – Scottsdale Unified School District

Rule: Article 15. Student Eligibility Rules, Section 10 Transfer Rule (15.10)

## **Reported Violation:**

Student did not report on his 550 form that he wrestled at Fountain Hills High School last year. Athletic Director from Fountain Hills called and informed me that he had wrestled last year.

## **Schools Corrective Action:**

Contests Forfeited. Student is filling out another 550 form with correct information. Student will sit out 50% of remaining dual meets.

#### **Executive Board Action:**

The Executive Board, in accordance with Article 16, Section 1 of the AIA Bylaws, placed the Desert Mountain High School **Boys' Wrestling Program** on **Advisement** for one year 1/16/24-1/16/25. **Nathan Slater abstains.** 

# **APACHE JUNCTION HIGH SCHOOL** – AJUSD

Rule: Article 15. Student Eligibility Rules, Section 2 Application of Eligibility Rules (15.2.3)
Rule: Article 43. Sports Medicine, Section 5 Heat Acclimatization Policy (43.5)

## **Reported Violation:**

I cleared a transfer student to compete at a wrestling tournament before he completed the required days of acclimatization to Arizona. I also do not know that he was a home-schooled student when he was in Oregon who was working on a curriculum that we will no accept, so he will not receive credits from us this fall.

## **Schools Corrective Action:**

In conjunction with district leadership I have instituted a hard and fast rule that all players will be held from competition for the first 10 days regardless of the situation. I have spoken with Dr. Dean as well as a couple of other seasoned AD's to ensure that I understand the acclimatization rules. I also worked with our registrar to create a new system that includes her sending me a transcript clearance sheet that will add to our current clearance process for new students.

## **Executive Board Action:**

The Executive Board, in accordance with Article 16, Section 1 of the AIA Bylaws, placed the Apache Junction High School **Activities Program** on **Advisement** for one year 1/16/24-1/16/25.

# **SCHOOL VIOLATIONS** – Cont'd

#### KINGMAN HIGH SCHOOL - Kingman Unified

Rule: Article 16. Penalties and Appeals, Section 1 Penalties (16.1.1.5)

## **Reported Violation:**

The girls basketball team was involved in a tournament over the weekend and through a series of events between officials and parents, had one of their games suspended part of the way through the 2nd quarter. The girls felt that the team was treated unfairly since the actions was none of their doing and felt that they may be officiated unfairly on Saturday due to the actions of others. So, they chose to protest and not participate in the scheduled game on Saturday. The coach failed to notify the tournament director and his own athletic director about the decision and the team came home. We then had to forfeit Saturday's game.

#### **Schools Corrective Action:**

The coach met with school administrators to discuss the situation and how it was a violation of the AIA rules and expectations. We discussed the importance of communication in situations like this and made sure the coach had the appropriate phone numbers. The coach was suspended from coaching the next game. There was also a discussion with the team to discuss the fact that this can not and will not happen again, along with possible consequences for it happening.

## **Executive Board Action:**

The Executive Board, in accordance with Article 16, Section 1 of the AIA Bylaws, placed the Kingman High School **Girls' Basketball Program** on **Warning** for one year 1/16/24-1/16/25.

## HORIZON HIGH SCHOOL - Paradise Valley Unified School District

Rule: Article 14. General Provisions, Section 4 Nonschool Participation (14.4.1)

## **Reported Violation:**

A member of Horizon's boys' soccer team participated in a club soccer tournament during the AIA season of competition.

## **Schools Corrective Action:**

Contests Forfeited. Horizon has removed the student athlete from our program and has contacted the appropriate schools about the violation. Horizon will forfeit all games that this athlete participated in.

#### **Executive Board Action:**

The Executive Board, in accordance with Article 16, Section 1 of the AIA Bylaws, placed the Horizon High School **Boys' Soccer Program** on **Advisement** for one year 1/16/24-1/16/25.

# **SCHOOL VIOLATIONS** – Cont'd

# MICA MOUNTAIN HIGH SCHOOL - Vail Unified School District

Rule: Article 14. General Provisions, Section 4 Nonschool Participation (14.4.1)

## **Reported Violation:**

A female soccer athlete participated in the United Futsal tournament in Phoenix on December 16<sup>th</sup> and 17<sup>th</sup> during the season of sport. As per the bylaw any contest the student participated in after surrendering their eligibility will be forfeited and the student in violation has been ruled ineligible for the remainder of the 2023-2024 soccer season.

## **Schools Corrective Action:**

Contest forfeited. The athlete was declared ineligible for the rest of the season. Sahuaro game will be forfeited. All coaches are educated on the Nonschool Participation bylaw prior to the beginning of the season. The coach had a parent meeting prior to the season and told the athletes the exact date when they could no longer participate in club activities. The administration team also holds a parent meeting at the beginning of each school year and explains the prior contact and non-school participation bylaw.

Mica Mountain is appealing the violation/forfeitures.

# **Executive Board Action:**

NEW information was presented by a member school supporting that Futsal is a separate sport from Soccer. Due to a lack of clarity and application of the Non-school participation bylaw as it relates to Futsal, the Executive Board is temporarily suspending the application of the bylaw to Futsal pending further review by our Board, Staff, and Soccer Advisory Committee. Schools and athletes will not be deemed in violation of the bylaw as it applies to Futsal during the current soccer season.

#### **MADISON HIGHLAND PREP -**

Rule: Article 17. Coaches and Coaching, Section 4 Coach's / Sponsor's Code of Ethics (17.4.3.3)

## **Reported Violation:**

During a conversation between MHP's Head football Coach and the sideline official regarding an unsportsmanlike conduct penalty, MHP's Head Coach made unintentional contact with the official while gesturing with his left hand. The official issued a second unsportsmanlike conduct penalty, and the Head Coach was ejected. The ejection report supports that all conversations between the officials and the coaches remained calm.

#### **Schools Corrective Action:**

Head Coach has been advised to keep his hands in his pockets and out of conversation heretofore. Additionally, the MHP Coaching staff has created a corrective action response to enforce appropriate interaction with game officials and ensure the game officials are treated with the respect they deserve. That plan has been attached to this report.

# **Executive Board Action:**

The Executive Board, in accordance with Article 16, Section 1 of the AIA Bylaws, placed the Madison Highland Prep **Football Program** on **Warning** for one year 1/16/24-1/16/25.
