NOTIFICATION OF INELIGIBILITY AND RIGHT TO APPEAL

PURPOSE OF FORM: This form is used to notify a student of his/her ineligibility and right to appeal. Ineligibility may occur for a number of reasons (i.e., initial ninth grade enrollment was in a high school other than the one in which the student is currently enrolled; parents have moved out of attendance zone, etc.).

HARDSHIP APPEAL: The Enrollment Rule (Article 15, Section 15.3, Paragraphs 15.3.4 and 15.3.6 only), Domicile Rule (Article 15, Section 15.5) and Transfer Rule (Article 15, Section 15.10) are the only rules, which are appealable. Such appeals must meet the criteria outlined under hardship eligibility (Article 15, Section 15.14).

EXAMPLES OF REASONS:

1. Your initial ninth grade enrollment was in a high school other than (Name of School).
2. You have been in attendance in (Name of School) less than one academic year.
3. Your parent(s) have moved out of (Name of School) attendance zone.

EXAMPLE OF APPLICABLE RULE:

Article 15. Student Eligibility Rules, Section 15.10.4 Transfer Rule Exceptions – Without Change Of Domicile.

1. Parents or Leal Guardians Moving Out of the District
 - a. Except for currently enrolled ninth grade students, a student whose attendance in a school has been less than one academic year and whose parents move out of the school attendance zone, shall be ineligible for further competition in interscholastic activities in that school starting at the conclusion of the current sports season.
