EXECUTIVE DIRECTOR REPORT

Mr. Don Logan reported on the recent AIA Racial Sensitivity Summit which was held with leaders from the northeast region. Mr. Logan indicated that the summit was held to engage and ensure stakeholders affected by recent allegations and share perceptions of the culture of the NE region. Mr. Logan discussed AIA's expectations and consequences of behavior of everyone involved. Creating a more controlled environment with Administrators on site – on both sides of the court – will deter and when necessary - stop inappropriate student chanting. Everyone agrees that sportsmanship needs to be the foundation of high school sports and games played with a sense of respect and honor. Dr. Slemmer thanked Mr. Logan for his leadership in facilitating the diversity summit.

Dr. Slemmer updated the Board on the wrestling tournament and the decision to postpone the tournament due to the number of reported skin infections. In his absence, Dr. Slemmer thanked Mr. Schmidt for his leadership in dealing with the situation and Mr. Visser for his diligence in working out the details when the decision was made to continue the tournament. Sr. Lynn agreed that the AIA did the best thing in postponing the tournament due to the seriousness of the reported infections. Dr. Slemmer also thanked everyone who worked the tournament and appreciates the integrity and hard work of everyone involved. Mr. VanWinkle thanked Mr. Visser for all his hard work in making the tournament happen. Mr. Bolitho was also recognized for updating and reporting results on 365.com.

The Board was provided a copy of the Legislative Council Meeting Agenda. Dr. Slemmer noted that AIA staff will be present at conference meetings to discuss and answer any questions regarding the proposed agenda items. Sr. Lynn reminded legislative council members of the Caucus which will be held at the AIA office on Thursday, March 6th at 3:00 p.m.

Dr. Slemmer reported on the 2014 NFHS Proposed Football Rules Changes and provided the Board with a copy of the proposed changes. Dr. Slemmer is encouraged by the rule changes and the effort to make the game safe.

In anticipation of the 2015-2016 computer scheduling process, which the Board oversees, it was determined that the Executive Board members will submit three (3) names to represent their conferences on the Computer Scheduling Committee, The names will be submitted and approved at the March 17th Executive Board meeting. The Computer Scheduling Committee will meet on Wednesday, April 9th at 10:00 a.m. at the AIA office.

It was reported that the Summit held at February Frenzy will be moved to April, as well as all AIAAA LTC classes.

The Board was shown the on-line course regarding harassment which will be available to all AIA sports officials. On a motion duly made, seconded and carried, the Board **voted to require** all officials to take the course before being assigned any games beginning with the Fall 2014 season. The course will be available online for officials to view at no cost beginning June 2014. Notification will be sent to all officials with registration materials.

EXECUTIVE DIRECTOR REPORT – Cont'd

Discussion was held regarding Yuma Union High School District's request to add FR Soccer for the 2014-15 school year and San Luis dropping their football program. On a motion duly made, seconded and carried, the Board <u>approved</u> YUHSD's request to add FR soccer and drop football at San Luis. YUHSD also requested an exception to AIA Bylaw 15.10.7.2 in order that SLHS currently enrolled students who have participated in the football program be allowed to open enroll to any of the YUHSD high schools to play football.

- 15.10.7 When Sport or Nonathletic Activity Is Dropped When a sport or nonathletic activity is dropped by a governing board, a student may transfer to a school that offers that sport or nonathletic activity and shall be eligible only in the sport or nonathletic activity that has been dropped at the school from which the student transferred. Said eligibility will be granted when the student enrolls in one of the following schools:
 - 15.10.7.1 A private or parochial high school in the county in which the parents are domiciled.
 - 15.10.7.2 The public high school within the same school district closest to the domicile of the parents.

On a motion duly, made, seconded and carried, the Board <u>denied</u> the request from YUHSD for an exception to AIA Bylaw 15.10.7.

Open Discussion – Current Issues

Sr. Lynn, AIAAA Executive Board Rep, noted concerns from schools – mostly 1A, 2A & 3A regarding cancellations and forfeitures of games. Discussion points:

- difference between cancellations and forfeitures power rankings
- current formula we used to include forfeits
- holding coach/school accountable for playing an ineligible player is forfeit enough?
- · expenses involved
- penalty
- logistics of small schools
- hold off scheduling small schools to see if they can field teams
- have to have a certain number of games for power ranking
- need a process from the 1A-3A

Sr. Lynn also reminded the Board that the AIAAA will host the national conference in 2017 and would like participation from Athletic Directors.

REQUEST - EXCEPTION TO AIA BYLAW 23.5 - MOUNTAIN VIEW (MARANA)

Rule: Article 23. Football, Section 23.5 Number of Games in Season

23.5 <u>NUMBER OF GAMES IN SEASON</u>

23.5.1 No school shall schedule more than ten varsity games.

Mountain View (Marana) is requesting an exception to the above bylaw and the following:

- Participate in the Global Football Game in Ireland during the 2014 football season
- Move the previously scheduled week 2 game vs. Cienega to Zero week (week 7 on the AIA standardized calendar (letter attached from Cienega)
- Begin fall practice week 4 rather than week 5 per AIA bylaw 23.2.3

SCHOOL VIOLATIONS

<u>FLAGSTAFF HIGH SCHOOL</u> reported a violation of the AIA Bylaws; namely, Article 10. Sanction Procedures, Section 10.2 Interstate Invitational Tournaments

Reported Violation:

Flagstaff Athletic Director reports – "Attached are three "Report of Violation" forms for Flagstaff High School. I am submitting these based on a conversation with Michele Staples where she indicated that I was in violation of Bylaw 10.2.1. I respectively submit these forms, but believe that I am not in violation of the Bylaw as written." Reports attached.

School's Corrective Action:

Per Athletic Director - "I assure you that at no point in time was my intent to violate or not follow the AIA bylaws. I believed that I was in compliance and had completed the required process."

Executive Board Action:

Executive Board, in accordance with Article 16, Section 16.1 of the AIA Bylaws, placed the Flagstaff High School **Activities Program** on **Advisement** for one year 2/18/14-2/18/15.

<u>LEE WILLIAMS HIGH SCHOOL</u> reported a violation of the AIA Bylaws; namely, Article 14. General Provisions, Section 14.2 Practice

Reported Violation:

Boys' and Girls' FR basketball teams scrimmaged a middle school boys' basketball team on 1/10/14.

School's Corrective Action:

Scrimmage was immediately stopped. Mandatory coaches meeting on 1/15/14 for all coaches and in-service of specific bylaw 14.2.2.

Executive Board Action:

Executive Board, in accordance with Article 16, Section 16.1 of the AIA Bylaws, placed the Lee Williams High School **Boys'/Girls' Basketball Programs** on **Warning** for one year 2/18/14-2/18/15.

SCHOOL VIOLATIONS

TEMPE HIGH SCHOOL reported a violation of the AIA Bylaws; namely,

Article 14. General Provisions, Section 14.4 Nonschool Participation

Reported Violation:

Ineligible boys' soccer player. Student played in holiday tournament with another soccer team on December 22nd.

School's Corrective Action:

Contests forfeited. Coach was told that this player was in Mexico over break. We talk and meet with every team before the season about not playing with another team during their season. He is a Spanish speaking student – have more translators when addressing teams.

Executive Board Action:

Executive Board, in accordance with Article 16, Section 16.1 of the AIA Bylaws, placed the Tempe High School **Boys' Soccer Program** on **Advisement** for one year 2/18/14-2/18/15.

<u>BOULDER CREEK HIGH SCHOOL</u> reported a violation of the AIA Bylaws; namely, <u>Article 15. Student Eligibility Rules, Section 15.7 Physical Examination Rule, Section 15.8 Parental or Legal</u> Guardian Consent Rule

Reported Violation:

Ineligible spiritline athlete. It was discovered during grade checks that student was not cleared to participate – no clearance packet on file. The coach had some information, but not a complete packet.

School's Corrective Action:

The student only cheered in games on the sidelines. He did not participate in national or state competitions. The Spiritline coach has been given an express directive to not allow any player to participate unless cleared from athletic office. She has also been told to review the bylaws on eligibility and participation. The student was immediately pulled from participation until a clearance packet is completed. All head coaches were reminded that students needed to be cleared by the athletic office before they participate in any athletic event.

Executive Board Action:

Executive Board, in accordance with Article 16, Section 16.1 of the AIA Bylaws, placed the Boulder Creek High School **Spiritline Program** on **Warning** for one year 2/18/14-2/18/15.

<u>AGUA FRIA HIGH SCHOOL</u> reported a violation of the AIA Bylaws; namely, <u>Article 16. Penalties & Appeals, Section 16.2 Ineligible Player</u>

Reported Violation:

Ineligible boys' soccer player. Transfer student was asked to complete a 520 Form based on change of domicile and change of guardianship due to financial reasons. This was confirmed in Step 2 of the 520 Form completed by the sending school's A.D. When the AFHS A.D. checked student's athletic file in late December after student got ejected from a game, the A.D. found that he had neglected to complete Step 3 of the 520 Form. In the process of completing Step 3, the AFHS A.D. realized that student had transferred from a private, parochial school within Maricopa County. Student was immediately stopped from competing. A.D. contacted the AIA seeking guidance. Student was removed from the team and AFHS is submitting an appeal regarding the forfeitures.

School's Corrective Action:

Contests forfeited. Moving forward, AFHS has developed a detailed, step-by-step process for processing transfers/520 Forms. The transfer student and family will work directly with the AFHS A.D. through each step of the process. Meticulous documentation will occur during each step of the process. A.D. will check team rosters submitted by coaches for each athletic contest verifying eligibility.

Executive Board Action:

Executive Board, in accordance with Article 16, Section 16.1 of the AIA Bylaws, placed the Agua Fria High School **Activities Program** on **Advisement** for one year 2/18/14-2/18/15.

<u>BISBEE HIGH SCHOOL</u> reported a violation of the AIA Bylaws; namely, <u>Article 16. Penalties & Appeals, Section 16.3 Sportsmanship Rule</u>

Reported Violation:

During a Varsity Girls' Basketball game vs. Tombstone, four (4) student athletes stepped off the bench and onto the floor when another team member was involved in play where she was pushed by an opposing player. The players did not run to where the incident was on the floor, but did take a few steps onto the court.

School's Corrective Action:

Contest not forfeited - officials allowed the game to continue. The final score was 40-15 in favor of Tombstone. All coaches have copies of most recent rule books for each sport. Girls' coach was brought in to review the rule. All coaches will be emailed a copy of the incident and the specific violation. Rules about entering the playing area will be addressed with all coaches prior to their season of sport. Before every home contest we read a sportsmanship code and will continue to do so. There will be a continual effort to emphasize good sportsmanship to all players, coaches and spectators.

Executive Board Action:

Executive Board, in accordance with Article 16, Section 16.1 of the AIA Bylaws, placed the Bisbee High School **Girls' Basketball Program** on **Advisement** for one year 2/18/14-2/18/15.

<u>MOUNTAIN VIEW (MESA) HIGH SCHOOL</u> reported a violation of the AIA Bylaws; namely, <u>Article 16. Penalties & Appeals, Section 16.3 Sportsmanship Rule</u>

Reported Violation:

During the boys' soccer game at Dobson, the Mountain View fans were asked to leave the stands during the game, exit the stadium and they complied. One parent walked onto the field and approached the center official to discuss the situation. The parent did not leave when motioned by the official. The Dobson SRO came onto the field, handcuffed and escorted the parent out of the stadium.

School's Corrective Action:

Parent has been banned from attending games for the rest of the season and was cited and has a court date to address the trespassing/failing to leave. Thorough investigation conducted. Administrators and security have been monitoring behavior of the spectators. Incident documented in police report.

Executive Board Action:

Executive Board Accepted the Report from Mountain View (Mesa) High School.

<u>MESQUITE HIGH SCHOOL</u> reported a violation of the AIA Bylaws; namely, Article 16. Penalties & Appeals, Section 16.3 Sportsmanship Rule

Reported Violation:

During the girls' basketball game with Dobson, a Mesquite parent was upset with the physical nature of game and perceived intentional conduct towards daughter by opposing team. He left the stands and went onto the court and confronted the opposing coach regarding this during the 2nd quarter of the contest. Home security and administration physically escorted the parent out of the gym with the assistance of other Mesquite parents.

School's Corrective Action:

Thorough investigation conducted. Additional security guards will be present for both home and away games regarding the team in question. Met with coaches and will examine requirement of each sport to have a uniform parent conduct policy to be a part of individual team expectations. Parent has been banned from any future afterschool activities involving GPS for the remainder of the 2013-2014 school year.

Executive Board Action:

Executive Board Accepted the Report from Mesquite High School

<u>KOFA HIGH SCHOOL</u> reported a violation of the AIA Bylaws; namely, <u>Article 17. Coaches & Coaching, Section 17.4 Coach's/Sponsor's Code of Ethics</u>

Reported Violation:

Boys' varsity head boys' soccer coach made an inappropriate remark in the local newspaper regarding the officials.

School's Corrective Action:

Handled at school level with Principal.

Executive Board Action:

Executive Board, in accordance with Article 16, Section 16.1 of the AIA Bylaws, placed the Kofa High School **Boys' Soccer Program** on **Advisement** for one year 2/18/14-2/18/15.

Dr. Slemmer commended Kofa High School for their action taken.

TREVOR G. BROWNE HIGH SCHOOL reported a violation of the AIA Bylaws; namely,

Article 21. Basketball, Section 21.5 Number of Games in Season

Article 36. Spiritline, Section 36.10 Coaches/Coaching

(1 of 2 violations)

Reported Violation:

Ineligible boys' varsity basketball player. Player was allowed to participate in more than 6 quarters the night of the game held on 1/17/14.

School's Corrective Action:

Contest forfeited. The varsity coach will sit out two games and be in-serviced on Article 21. The coach said he did not do it. However, overwhelming evidence shows that he did.

Executive Board Action:

Executive Board, in accordance with Article 16, Section 16.1 of the AIA Bylaws, placed the Trevor Browne High School **Boys' Basketball Program** on **Advisement** for one year 2/18/14-2/18/15.

(2 of 2 violations)

Reported Violation:

Spiritline coach did not attend a NFHS Spirit Rules interpretation class this year.

School's Corrective Action:

Spiritline coach has resigned her position with the school. The Spiritline Bylaw was explained to the temporary coach. Will ensure the new coach is in-serviced.

Executive Board Action:

Executive Board, in accordance with Article 16, Section 16.1 of the AIA Bylaws, placed the Trevor Browne High School **Spiritline Program** on **Advisement** for one year 2/18/14-2/18/15.

HAYDEN HIGH SCHOOL reported a violation of the AIA Bylaws; namely,

Article 36. Spiritline, Section 36.10 Coaches/Coaching

Reported Violation:

Spiritline coach did not attend a NFH Spirit Rules interpretation class and did not take the exam.

School's Corrective Action:

A.D. was made aware of the requirements of the Spiritline coach. Met with Superintendent/Principal, explained violation and ways to ensure that this violation does not occur again. A.D. met with Spiritline coach and informed coach to make arrangements to take the course in July with A.D. supervising.

Executive Board Action:

Executive Board, in accordance with Article 16, Section 16.1 of the AIA Bylaws, placed the Hayden High School **Spiritline Program** on **Advisement** for one year 2/18/14-2/18/15.

<u>CIBECUE HIGH SCHOOL</u> reported a violation of the AIA Bylaws; namely, Article 36. Spiritline, Section 36.10 Coaches/Coaching

Reported Violation:

Spiritline coach did not attend NFHS Spirit Rules or AACCA course through AIA for the 2013-2014 school year.

School's Corrective Action:

Spiritline coach has been immediately suspended from participation in future athletic contests for the 2013-2014 school year. The sponsor has been notified and orientated of her responsibilities and duties as a sponsor. However, the current sponsor has completed the Fundamentals of Coaching; First Aid/CPR and Concussion course as required by our community school administration and governing board. Certification documents are on file with the school. The sponsor will complete the required courses when they become available.

Executive Board Action:

Executive Board, in accordance with Article 16, Section 16.1 of the AIA Bylaws, placed the Cibecue High School **Spiritline Program** on **Advisement** for one year 2/18/14-2/18/15.

<u>CARL HAYDEN HIGH SCHOOL</u> reported a violation of the AIA Bylaws; namely, Article 36. Spiritline, Section 36.10 Coaches/Coaching

Reported Violation:

Spiritline coaches did not attend a NFHS Spirit Rules course or AACCA course through the AIA for the 2013-14 school year. The coaches for this program are part of the activities program, but their sponsors paperwork is turned into a different office on campus.

School's Corrective Action:

All spiritline sponsor paperwork will again be submitted via the Athletic/Activity office for clearance purpose.

Executive Board Action:

Executive Board, in accordance with Article 16, Section 16.1 of the AIA Bylaws, placed the Carl Hayden High School **Spiritline Program** on **Advisement** for one year 2/18/14-2/18/15.

<u>JOSEPH CITY HIGH SCHOOL</u> reported a violation of the AIA Bylaws; namely, <u>Article 36. Spiritline, Section 36.10 Coaches/Coaching</u>

Reported Violation:

Spiritline coaches did not attend a NFHS Spirit Rules interpretation class this year.

School's Corrective Action:

Coaches will take the course as soon as it is available.

Executive Board Action:
