Agenda Items:

- Approval of Minutes April 12, 2022: Dave H. moved to approve; 2nd by Yancey D.; unanimously approved.
- 2. Confirmation of Chairman: Kevin Belcher (Central) for 2023-24
- 3. Football reclassification Executive Board approved May 2023
 - a. 2-yr Scheduling Block.
 - b. 2.0 +/- Standard Deviation (No Rounding).
 - c. Effective July 1, 2023.
 - d. 2024 FB Schedules will be the same home/away reversed.
 (Conferences will adjust as needed such as out of state games)

- 4. NFHS rule changes and Points of Emphasis for Fall 2023 Tyler C:
 - a. **Contrasting #s required on jerseys for 2024**
 - b. Towels worn by athletes.
 - i. Towels do not have to match the uniform color scheme
 - 1. Towel must be at least a fist width no thin stripped towels.
 - 2. Only types of logos permitted on the towel: Brand name and team logo
 - c. Fumbles occurring near sidelines.
 - i. A Player can be in the air (not contacting the turf and tip the ball back in bounds)
 - ii. A Player must have at least 1-foot in bounds and not touching any part of the out of bounds.
 - d. Defenseless receiver penalty focus
 - i. A receiver that is contacted unnecessarily or with excessive force.
 - e. Line of scrimmage penalties
 - i. All flags thrown will be marked off from the line of scrimmage.
 - ii. Penalties will not be imposed from behind the line of scrimmage.
- 5. Emphasis on improved communication between officials and head coaches
- 6. Direct pushing/contacting of a player to advance the ball.
 - a. Will be penalized as 5 yd aiding the runner.
- 7. Eye Black
 - a. Single stripe
- 8. Visor Rule
 - a. No color/No tint

- 9. Officials Dept. Sidelines Brian G.
 - a. Continuing improved communication with coaches
 - i. Professionalism
 - ii. Communication
 - iii. Sportsmanship
 - iv. AIA is always looking for new officials asking HFB Coaches to let AIA know 5 graduating seniors who would be interested. AIA can set them up in a mentoring program.
- Padded Spring FB Practices & Comp. during Spring Practices Dave Huffine & Dana Zupke (6A)
 a. Propose having padded spring practices like TX, FL etc. and allow competition.
 - i. Pros- improved technique and skills; development of athletes against other state who have contact during spring. Recruitment benefits include college coaches who can observe.
 - ii. Cons: Quorum discussion on liability, helmet reconditioning issues, how to manage contact against fall contact.
 - Joe P. AIA insurance concerns; SMAC concerns with acclimatization for spring FB w/contact.
 - Joe P. if the membership wants Competition, why have Spring Practice? Membership would lose insurance coverage.

11. New Business

- a. Proposal to Football Advisory Committee by Tyler C.
 - 38% of games won last year were by 35pts. AZ is the lone state who currently exercise the 42pt mercy rule. Mercy rule proposed change in **RED**:
 - i. 42pts first half = running clock
 - ii. 35 pts after halftime = running clockOfficials' timeout following 35 pt margin score = meeting between coaches to discuss time clock management of contest

- b. Dana Z. brought up concern of some FB programs dropping JV schedule and keeping Frosh/Soph; then playing Soph heavy team against other teams Frosh.
- c. Greg D. brought up concerns about the AIA MaxPreps Rating system not able to understand the ratings.
 - i. Mr. Hines explained the ratings are proprietary Maxpreps is the owner, and the rating method is not shared.
 - ii. Key items of the AIA Maxpreps rankings:
 - 14-point score differential more value in a win by 14 or more.

- AIA ratings are not predictive must play the game to get the value.
- As more games are played, AIA ratings look closer like the national Maxpreps ratings.
- AIA Staff will add this information to the 2023 Pre-season Coaches Power Point to assist in understanding the AIA rating system.
