Unified Badminton 2025-26 Season Fact Sheet





OVERVIEW

- Students with intellectual disabilities (Unified Athletes) and students without intellectual disabilities (Unified Partners) compete together on co-ed Badminton Doubles teams.
- Each Doubles pair consists of one Unified Athlete and one Unified Partner.

DIVISIONS

To ensure player safety, the following divisions have been established to accommodate teams of varying skill and ability level –

- **♦ GOLD DIVISION**
 - Adequate understanding of the rules
 - Advanced Playing Skills
- **♦ SILVER DIVISION**
 - ♦ Basic understanding of the rules
 - ♦ Novice Playing Skills

UNIFIED BADMINTON

Unified Badminton is AIA-sanctioned sport supported by and in conjunction with Special Olympics Arizona (SOAZ), which has been established to foster inclusion, camaraderie, and the development of meaningful relationships between students with intellectual disabilities (Unified Athletes) and students without intellectual disabilities (Unified Partners) as high school athletes, teammates, and training partners.

2025-26 REGULAR SEASON

- SOAZ's "8-practice" rule is in effect for participation in AIA Unified Sports. Practices must be at least one hour to qualify as a sanctioned practice, and all eight hours of practice must be completed prior to the team's first competition.
- Unified Badminton teams are encouraged to schedule as many regular season interscholastic contests (matches) as they'd like under AIA rules. Please note there is a minimum number of regular season contests required to qualify for the state championship.

2025 UNIFIED BADMINTON STATE CHAMPIONSHIP

- In order to qualify for the 2025 State Championship tournament -
 - Unified Doubles teams must participate in a <u>minimum</u> of two interscholastic contests (matches) against other high school Unified Badminton teams during the regular season.
 - o Teams must attend a qualifying Unified Badminton Sectionals tournament in the valley.
 - Thursday, September 16th (East Valley)
 9:00am 1:30pm @ Westwood High School
 - Thursday, September 18th (West Valley)
 9:00am 1:30pm @ Valley Vista High School
 - The top twelve Unified Doubles teams from each division at the conclusion of all Unified Sectionals tournaments will advance to the State Championship.
- This tournament will take place in conjunction with the 2025 AIA State Badminton Championships held:
 - Saturday, October 25th, 2025
 - 8900am to 1:00pm
 - Independence High School

AIA UNIFIED SPORTS STUDENT ELIGIBILITY AND CLEARANCE



UNIFIED SPORTS TEAM ROLES

- Unified Athlete an enrolled student with an intellectual/developmental disability
- Unified Partner an enrolled student without an intellectual/developmental disability

UNIFIED ATHLETE ELIGIBILITY

- Any enrolled student with an intellectual disability who meets both the Unified Athlete eligibility statement below and all
 requirements of the AIA and school district's athletic clearance policy is eligible to participate as a Unified Athlete in AIA
 Unified Sports.
- An individual is considered to have intellectual disabilities for purposes of determining his or her eligibility to participate
 in Unified Sports® if that individual:
 - Has been identified by an agency or professional as having intellectual disabilities as determined by their localities;
 or
 - Has been identified by the school as receiving special education and related services consistent with an individual education program based on a cognitive, developmental and/or intellectual disability.

UNIFIED PARTNER ELIGIBILITY

- Any enrolled student who meets all requirements of the AIA and school district's athletic clearance policy is eligible to
 participate as a Unified Partner in AIA Unified Sports.
- Any student competing in an individual sport (i.e. Swim, Track & Field) IS eligible to participate as a Unified Partner in the same sport, EXCEPT during the following circumstances
 - Any competition at which the student is attempting to qualify for advancement to a state-level competition in any non-Unified event.
 - o Any state-level competition at which the student is competing in any non-Unified events.
- Any student competing in a team sport (i.e. Flag Football and Basketball) at the <u>varsity level</u> is *NOT* eligible to compete
 as a Unified Partner in the <u>same sport</u>.
 - o Example A varsity soccer player is NOT eliqible to compete on the Unified Soccer team
 - o Example A varsity soccer player <u>IS</u> eligible to compete on a Unified Basketball team.

AIA STUDENT ATHLETIC CLEARANCE POLICY

- All participants in interscholastic activities must be in compliance with all student eligibility rules. The student eligibility rules are enumerated and presented in detail in Article 15 of the AIA Bylaws.
- **Physical Examination Rule (Article 15.7)** states a student shall not be allowed to practice or compete in interscholastic athletics until there is a record of a preparticipation physical examination on file with the school. The preparticipation physical examination forms provided by the AIA include three parts:
 - 1. <u>Annual Preparticipation Physical EVALUATION</u> To be completed and signed by the parent or legal guardian and the student athlete. This form must also be signed by the examining medical provider. (Form 15.7-A)
 - 2. <u>Annual Preparticipation Physical EXAMINATION</u> To be completed and signed by the examining medical provider. (Form 15.7-B)
 - 3. <u>Annual Preparticipation ACKNOWLEDGEMENT</u> To be completed and signed by parent or guardian and student athlete. (Form 15.7-C).
 - 4. <u>Annual Preparticipation Consent to Treat Form</u> To be completed and signed by parent or guardian and student athlete. (Form 15.7-D).
 - 5. Unified Sports Participant Release To be completed and signed by parent or quardian. (Form 15.7-E).
- **Parental or Legal Guardian Consent Rule (Article 15.8)** states that parental or legal guardian consent is required before a student can be eligible to practice or compete in interscholastic competition. All students shall have appropriate permission in which the parent or legal guardian authorized participation on file with the school.

SCHOOL/DISTRICT ATHLETIC CLEARANCE POLICY

• Unified Athletes and Unified Partners are to be treated and recognized as AIA high school athletes, and will be expected to adhere to any and all district/school policies and procedures regarding student athletic participation and clearance.
