<b>Seeding Criteria:</b>	<ol style="list-style-type: none"> <li>1. Minimum of 7 Boy vs Boy matches overall to be seeded</li> <li>2. Returning previous year's Arizona State placer</li> <li>3. *Overall season win % (Multiple undefeated wrestlers with no other criteria high seed goes the most wins)</li> <li>4. Trackwrestling will take into account all common opponents to determine seeding positions</li> <li>5. Head-To-Head will supersede #1, #3, &amp; #4</li> </ol>
