# WILLIAMS FIELD HIGH SCHOOL – Higley Unified

Rule: Article 14. General Provisions, Section 2 Practice (14.2.2)

Rule: Article 14. General Provisions, Section 4 Nonschool Participation (14.4.1)

Rule: Article 15. Student Eligibility Rules. Section 3 Enrollment Rule (15.3.1)

#### **Reported Violation:**

Members of the boys' volleyball team leading up to the state tournament engaged in a scrimmage that included individuals not enrolled at the member school.

# **Schools Corrective Action:**

Contest forfeited. Coaches' professional development will include a more in-depth explanation of the pertinent bylaws and education on who may participate in practices during the season of sport.

#### **Executive Board Action:**

The Executive Board, in accordance with Article 16, Section 1 of the AIA Bylaws, placed the Williams Field High School **Boys' Volleyball Program** on **Probation** for one year 8/12/24-8/12/25, vacated all 2024 tournament games and vacated the 2024 championship title.

On a secondary motion made, seconded and carried the Executive Board moved the 2024 boys' volleyball state championship title to Casteel High School.

Based on the following corrective actions taken by Higley Unified School District and Williams Field High School

- Coach will no longer be on Williams Field staff
- The school instituted a more specific annual sign off for coaches and players to acknowledge review and compliance with pertinent bylaws and other coaching responsibilities.
- The school added an acknowledgement by parents in RMA/Aktiviate indicting that they have read bylaw 14.4.1 and 15.11
- Loss of championship title from 2024 season

On a motion made, seconded, and carried the Executive Board **rescinded** the probation and placed the Williams Field High School **Boys' Volleyball Program** on **Warning** for one year 8/12/24-8/12/25.

#### **Reported Violation:**

During a spot check, AP and AD lined up team and checked that all students were cleared. At that time it was revealed that some students had not completed all required paperwork.

# **Schools Corrective Action:**

AP and AD have and will continue to do spot checks throughout the season to ensure all students have required paperwork in. We will review processes with all head coaches. Football coaches is going through internal disciplinary action.

# **Executive Board Action:**

The Executive Board, in accordance with Article 16, Section 1 of the AIA Bylaws, placed the Tucson High School **Football Program** on **Warning** for one year 9/10/24-9/10/25.

# SABINO HIGH SCHOOL - Tucson Unified School District

Rule: Article 15. Student Eligibility Rules, Section 12 Recruitment Rule (15.12)

# **Reported Violation:**

Sabino administration was notified that there was an athlete participating on the summer Sabino girls' basketball team that was not an enrolled student at Sabino High School. The student is currently a middle school student. The coach allowed the student to participate despite being directed not to do so by the school administration.

# **Schools Corrective Action:**

Prior to the end of summer, a meeting was held and all coaches were notified that any student participating in Sabino athletics during the off season and summer season must be Sabino students and cleared in ATS. The coach will be receiving a letter of reprimand. Sabino will continue to meet with coaches at the beginning of each season as well as the start of summer to go over AIA and District policies and procedures.

#### **Executive Board Action:**

The Executive Board, in accordance with Article 16, Section 1 of the AIA Bylaws, **accepted** the Sabino High School report.

Two players participate in practice from August 5<sup>th</sup> through 7<sup>th</sup> without being cleared by MUHS.

# **Schools Corrective Action:**

This coach is no longer with the team. Our new coach is aware of Mingus policies.

The Executive Board, in accordance with Article 16, Section 1 of the AIA Bylaws, placed the Mingus Union High School **Football Program** on **Warning** for one year 9/10/24-9/10/25.

# MINGUS UNION HIGH SCHOOL - Mingus Union

Rule: Article 14. General Provisions, Section 2 Practice (14.2.1)

#### **Reported Violation:**

Basketball coach had an open gym on 8/18/24 (Sunday), players were present

#### **Schools Corrective Action:**

Coach was not aware of the rule, occurred one time. Conference with coach and reviewed AIA bylaws.

#### **Executive Board Action:**

The Executive Board, in accordance with Article 16, Section 1 of the AIA Bylaws, placed the Mingus Union High School **Boys' Basketball Program** on **Advisement** for one year 9/10/24-9/10/25.

# **SHADOW RIDGE HIGH SCHOOL** – Dysart Unified School District

Rule: Article 15. Student Eligibility Rules, Section 3 Enrollment Rule (15.3.1)

#### **Reported Violation:**

Student was approved for open enrollment on July 29, 2004 through our District Office to transfer from Valley Vista High School to Shadow Ridge High School. Student attended our cheer tryout on July 31, 2024. Student was selected to be on the team for the 2024-2025 school year. Student practiced with our cheer team on their first practice on August 5, 2024. It was confirmed on August 6, 2024 the student did not transfer to Shadow Ridge yet. Student was notified on August 6, 2024 that they are not eligible to practice with our cheer team.

#### **Schools Corrective Action:**

Shadow Ridge High School Athletic Department will screen every student in Aktivate to make sure they are Shadow Ridge students prior to approving them to tryout for our teams.

#### **Executive Board Action:**

The Executive Board, in accordance with Article 16, Section 1 of the AIA Bylaws, placed the Shadow Ridge High School **Spiritline Program** on **Advisement** for one year 9/10/24-9/10/25.

# PRESCOTT HIGH SCHOOL - Prescott Unified

Rule: Article 15. Student Eligibility Rules, Section 1 Student Eligibility Requirements (15.1.1) Rule: Article 15. Student Eligibility Rules, Section 7 Physical Examination Rule (15.7.1)

#### **Reported Violation:**

We had a foreign exchange student from Brazil who was given the registration paperwork and walked through the steps. Even though she was told not to go to practice til she was cleared she went to volleyball tryouts. The coaches sent her back up to the office with one of their managers to get her cleared. They met with one of our Assistant Principals who oversee our foreign exchange students and was told she was clear on his end. The manager and student took that to. Mean that she was cleared for Final Forms when he was only talking about school. The coach took the word of the manager and athlete over seeing the actual clearance slip from the athletic department

#### **Schools Corrective Action:**

Reminder to coach to have physical clearance slip before athlete is allowed to practice.

#### **Executive Board Action:**

The Executive Board, in accordance with Article 16, Section 1 of the AIA Bylaws, placed the Prescott High School **Volleyball Program** on **Warning** for one year 9/10/24-9/10/25.

# **Reported Violation:**

Head volleyball Coach allowed a freshman student athlete to attend 2 practices before she realized that the student was not cleared by our office. The student had not paid their fee, presented a physical a signed packet. The coach failed to check the sheet provided by the office.

#### **Schools Corrective Action:**

The coach was instructed to go strictly off the check sheet provided by the office and not what the student tells them.

#### **Executive Board Action:**

The Executive Board, in accordance with Article 16, Section 1 of the AIA Bylaws, placed the Duncan High School **Volleyball Program** on **Warning** for one year 9/10/24-9/10/25.

#### **SETON CATHOLIC PREP** – Catholic Diocese of Phoenix

Rule: Article 24. Football, Section 3 Pre-Competition Practice (24.3.1)

# **Reported Violation:**

On Wednesday, August 21<sup>st</sup>, our Spiritline team performed during our football scrimmage versus Paradise Valley. This was an oversight on our new athletic administrative staff and new cheer and pom coaches.

#### **Schools Corrective Action:**

The athletic director will implement comprehensive training sessions for the athletic department and coaching staff to reinforce the importance of adhering to AIA policies regarding team scrimmages. This training will include detailed guidance on the specific regulations to prevent any future violations.

#### **Executive Board Action:**

The Executive Board, in accordance with Article 16, Section 1 of the AIA Bylaws, placed the Seton Catholic Prep **Spiritline Program** on **Advisement** for one year 9/10/24-9/10/25.

# REQUEST - VOLLEYBALL - SEASON OF SPORT EXCEPTION

Casteel High School has been invited to one of the top tournaments in the country in Hawaii. The tournament is prestigious and has the likes of Nationally top 20 ranked teams in the country.

The caveat is that traditionally this tourney starts the week of tryouts which is a week and a half before our first date of contest. Last year at the Women's Volleyball advisory committee the question was raised on how to enter the National stage as a state.

We are reaching out to see what the process would be to formally request an exception to play in this tourney. Our coach believes with the team we return we have an opportunity to compete for the # 1 team in the US.

# AMENDMENT - NIL (Name, Image, Likeness) BYLAW - UPDATE

15.11.1.2.3. The compensation is not provided by the school, a booster club, a collective, or any person/entity acting as an agent on behalf of the school or athletic program.

No student-athlete may be a member of nor receive compensation or any other benefit from a Collective or NIL Club. A Collective is defined as any group organized or existing for the purpose of compensating or benefiting an individual student athlete or a group of student athletes of a member school. NIL Clubs are defined as a group of student athletes organized or existing for the purpose of soliciting funds or other benefits from fans, members or other sources, managing or promoting NIL activities of student athletes or otherwise providing funds or other benefits to an individual student athlete or group of student athletes.

Booster Clubs are not considered Collectives or NIL Clubs if such Booster Club is operated under the supervision of a member school and provides monetary or other benefits to school athletic facilities, school athletic equipment, school team meals or other school team benefits rather than to an individual student athlete or group of student athletes.

On a motion made, seconded, and carried the Executive Board <u>approved</u> on <u>Emergency Legislation</u> the above amendment to Article 15.

#### SPORTS MEDICINE ADVISORY COMMITTEE - MEDICAL INTERVENTION

Medical interventions which increase the risk of disease exacerbation or additional injury are never appropriate on the day of competition, or on any other day, for a high school student-athlete. There are three steps of decision making for the basis of the Return to Play decision. These include evaluation of health risks, participation risks, and any factors in decision modification. If a disease process or injury is not adequately controlled by the day of competition to allow safe clearance for play with full function, then invasive medical procedures on the day of competition, performed with the sole purpose of enabling the student-athlete to participate, are philosophically inappropriate and shall not be performed on site. These prohibitive procedures are to include IV's, joint injections, and prescription strength medications not prescribed appropriately to the student athlete.

On a motion made, seconded, and carried the Executive Board **approved** the above policy.
