ESPORTS: MARVEL RIVALS PRESENTATION

Members of the Esports Advisory Committee, Kenya Corrigan and Robert LaPlante, presented a new and popular game the committee is hopeful to have approved as an AIA Esports Game.

- "Marvel Rivals" is an exciting team-based video game that combines strategy, action, and iconic characters from the Marvel universe.
- Players form teams of heroes or villains to engage in dynamic battles across various Marvel-themed environments.

ACTION ITEMS:

SCHOOL VIOLATIONS

PARADISE HONORS HIGH SCHOOL – Charter

Rule: Article 15. Student Eligibility Rules, Section 10 Transfer Rule (15.10)

Reported Violation:

A student transfer was allowed to play in tennis matches prior to sitting the required half of the season. No 550 was complete.

Schools Corrective Action:

Coaches will be in-serviced on bylaw 15-10. All athletes will be screened by the coaches PRIOR to being allowed to work with the team in any way. The athletic department will add transfer questionnaires to Register My Athlete so we can identify transfer students and make sure they are processed correctly prior to the season starting.

Executive Board Action:

The Executive Board, in accordance with Article 16, Section 1 of the AIA Bylaws, placed the Paradise Honors High School **Activities Program** on **Advisement** for one year 2/18/25-2/18/26.

SKYLINE HIGH SCHOOL – Mesa Public Schools

Rule: Article 15. Student Eligibility Rules, Section 3 Enrollment Rule (15.3.1)

Reported Violation:

A home school football athlete was brought in by a parent who is an employee of MPS to enroll their home school student at Skyline. The athlete was registered by our Registrars assistant and enrolled in a JROTC class as well as a football class. The registrar assistant failed to obtain the Affidavit of Intent to Homeschool and the registrar and the AD weren't notified of the home school student enrolling. The counselor also didn't catch the mistake made by the registrar assistant when they set up the student with his schedule. The athlete filled out his information on RMA and because he was enrolled at Skyline, it didn't raise a red flag for the athletics secretary. The athletics secretary was able to catch that he was a homeschooled student when it came time to run eligibility. The athlete is a freshman, so per the eligibility timeline, the athletic secretary did not run grades on him until Sept. 3rd. This was a month after tryouts. Once she noticed he was a homeschooled student without an affidavit on file, she notified the previous AD that he was not registered correctly. There was a chance in AD position at Skyline during the current football season and the resulting violation was never brought to the attention of the new AD until it was found during our process of reviewing our home school students. It was also determined that the student did not live in our school boundary.

Schools Corrective Action:

The AD met with the school principal and the registrar to review the policy and procedures of enrolling a homeschool student who is planning on attending Skyline and participating in athletics. The purpose of the procedures is to ensure the AD is involved in the process, once a home school student has been identified as a potential athlete on the campus. See document for roles and procedures we will follow.

Executive Board Action:

The Executive Board, in accordance with Article 16, Section 1 of the AIA Bylaws, placed the Skyline High School **Activities Program** on **Advisement** for one year 2/18/25-2/18/26.

ALHAMBRA HIGH SCHOOL - Phoenix Union High School District

Rule: Article 14. General Provisions, Section 4 Nonschool Participation (14.4.1)

Reported Violation:

The Alhambra boys' soccer player participated in a private practice session with an outside coach and another non PXU Player.

Schools Corrective Action:

Contest forfeited. The rule of "nonparticipation" was reiterated with all players. All players were told not to participate in outside practices with private coaches. The AD will contact the GCU Men's Soccer Club player to notify him of the rule, and request that they do not contact our players for training.

Executive Board Action:

The Executive Board, in accordance with Article 16, Section 1 of the AIA Bylaws, placed the Alhambra High School **Boys' Soccer Program** on **Advisement** for one year 2/18/25-2/18/26.

NOGALES HIGH SCHOOL – Nogales Unified

Rule: Article 14. General Provisions, Section 4 Nonschool Participation (14.4.1)

Reported Violation:

It was reported that 3 of our student-athletes with JVB boys' soccer participated in a non-school club tournament the weekend of 1/17-1/20. Upon investigation, it was confirmed these students were in violation of 14.4.1, having participated with their club team, RSL, in a club tournament that weekend.

Schools Corrective Action:

Students and parents were reminded article 14.4.1, and how it affects eligibility and contest forfeitures. The Athletic Department will continue to provide education during preseason meetings on topics relating to student-athlete eligibility.

Executive Board Action:

The Executive Board, in accordance with Article 16, Section 1 of the AIA Bylaws, placed the Nogales High School **Boys' Soccer Program** on **Advisement** for one year 2/18/25-2/18/26.

GILA RIDGE HIGH SCHOOL - Yuma Union High School District

Rule: Article 15. Student Eligibility Rules, Section 3 Enrollment Rule (15.3.1.2)

Reported Violation:

A family came in to sign their two student-athletes up for wrestling for the 4th year in a row at Gila Ridge. The family indicated that they are now receiving ESA funds and are enrolled in an online charter school. Wrestling season 2023-2024, the family provided an Affidavit of Intent from the Yuma County School Superintendent's office and indicated both students were being homeschooled.

Schools Corrective Action:

As part of the athletic clearance process, home school or ESA students must go through a checklist to ensure athletic eligibility. The athletic department will review this checklist, which requires families to submit specific documentation, which includes an academic transcript. By reviewing the transcripts, GRHS athletic department will be able to determine if a student was previously enrolled in another school in the same year as they were to be homeschooled or on an ESA contract.

Executive Board Action:

The Executive Board, in accordance with Article 16, Section 1 of the AIA Bylaws, placed the Gila Ridge High School **Activities Program** on **Advisement** for one year 2/18/25-2/18/26.

GILA RIDGE HIGH SCHOOL - Yuma Union High School District

Rule: Article 15. Student Eligibility Rules, Section 7 Physical Examination Rule (15.7.1)

Rule: Article 15. Student Eligibility Rules, Section 8 Parental or Legal Guardian Consent Rule (15.8.1)

Reported Violation:

Boys' wrestling athlete participated in practice without having a physical on hand or parental consent.

Schools Corrective Action:

GRHS will provide training on Article 15 of the AIA bylaws to stress the importance of the clearance process.

Executive Board Action:

The Executive Board, in accordance with Article 16, Section 1 of the AIA Bylaws, placed the Gila Ridge High School **Activities Program** on **Warning** for one year 2/18/25-2/18/26.

CHINLE HIGH SCHOOL – Chinle Unified

Rule: Article 22. Basketball, Section 5 Number of Games in Season (22.5.3)

Reported Violation:

Boys' basketball athlete played in more than 6 quarters on 1/17 against Tuba City.

Schools Corrective Action:

Contest forfeited. To ensure compliance and prevent future occurrences, the following steps will be implemented: 1. Mandatory AIA Bylaw Training. 2. Policy Integration into the Athletic Handbook. 3. Ongoing Training and Monitoring.

Executive Board Action:

The Executive Board, in accordance with Article 16, Section 1 of the AIA Bylaws, placed the Chinle High School **Boys' Basketball Program** on **Advisement** for one year 2/18/25-2/18/26.

TREVOR G BROWNE HIGH SCHOOL - Phoenix Union High School District

Rule: Article 22. Basketball, Section 5 Number of Games in Season (22.5.3)

Reported Violation:

Our varsity coach played a JV girls' basketball player for three quarters after she had already played four quarters on JV. So, he violated the 6 quarter rule. We verified.

Schools Corrective Action:

Contest forfeited. I have reminded our girls coach that he MUST verify the quarters a player can play prior to the start of his game. I also let the JV Coach know they need better communication as he was sitting on the bench when this occurred.

Executive Board Action:

The Executive Board, in accordance with Article 16, Section 1 of the AIA Bylaws, placed the Trevor G Browne High School **Girls' Basketball Program** on **Advisement** for one year 2/18/25-2/18/26.

CASTEEL HIGH SCHOOL - Chandler Unified School District

Rule: Article 14. General Provisions, Section 4 Nonschool Participation (14.4.1)

Reported Violation:

Student boys' soccer player participated in an MLS Next Game on Saturday, 1/11/2025.

Schools Corrective Action:

Contest forfeited. 14.4.1 is defined in per season parent meeting and reiterated by coaches.

Executive Board Action:

The Executive Board, in accordance with Article 16, Section 1 of the AIA Bylaws, placed the Casteel High School **Boys' Soccer Program** on **Advisement** for one year 2/18/25-2/18/26.

COPPER CANYON HIGH SCHOOL – Tolleson Union High School District

Rule: Article 19. Policies and Procedures, Section 1 Violations (19.1.1)

Reported Violation:

During a boys' soccer tournament game between Copper Canyon and Highland, our coach from CC decided to stop the game. Both teams were playing a physical game that escalated in the second half. The sideline referee was yelling at the middle referee to get control of the game and to pay attention to her calls. In the second half, a hard foul occurred on a Copper Canyon player, leading to a scuffle between a Copper Canyon player and a Highland player. Our coach felt that the center referee had lost control of the game and, considering the safety of his players, decided it was best to stop the game.

Schools Corrective Action:

I educated the coach that it is a violation to stop a contest. I explained to the coach he should make attempts to call the Athletic Director to explain the situation.

Executive Board Action:

The Executive Board, in accordance with Article 16, Section 1 of the AIA Bylaws, placed the Copper Canyon High School **Boys' Soccer Program** on **Warning** for one year 2/18/25-2/18/26.

SAFFORD HIGH SCHOOL – Safford Unified

Rule: Article 14. Policies and Procedures, Section 2 Practice (14.2.1)

Rule: Article 17. Coaches and Coaching, Section 5 Open Facilities (17.5.1.1)

Reported Violation:

It was discovered on January 7th that boys' basketball was utilizing the gym on a Sunday by a volunteer assistant coach. The coach held an open gym/shoot around on Friday January 3rd. The invite was communicated to the varsity team via the Remind app.

Schools Corrective Action:

Given the fact that the assistant coach was educated and acknowledged the SUSD, SHS and AIA policies, yet made the decision to open the gym on a Sunday without permission or knowledge by the head coach or school, abuse of District policy (key), was insubordinate and deceptive, I took the following actions:

- 1. Assistant coach was terminated. He is not eligible for hire as a coach in any capacity within any of our programs.
- 2. The district personnel will be more diligent in the collection of keys.
- 3. I will continue to emphasize the bylaw (i.e. Real-life example and consequences to our program). I met with basketball staff and players to re-educate.

Executive Board Action:

The Executive Board, in accordance with Article 16, Section 1 of the AIA Bylaws, placed the Safford High School **Boys' Basketball Program** on **Advisement** for one year 2/18/25-2/18/26.

AMENDMENT – ARTICLE 30 – TENNIS

30.10 POST-SEASON TOURNAMENTS

30.10.1 Post-Season Tournaments

30.10.1.2 There shall be Individual Champions and Team Champions for both boys and girls.

30.10.1.2.1 There shall be individual and/or team post-season tournaments as determined by the Executive Board

30.10.1.2.1.1 Losers in the semifinal round shall play a consolation round.

Rationale: This rule has not been followed for many years.

On a motion made, seconded, and carried the Executive Board <u>approved</u> the above policy and procedure amendment.

AMENDMENT – ARTICLE 30 – TENNIS

30.10 POST-SEASON TOURNAMENTS

30.10.3 <u>Practice on Site</u> - A practice or competition on the site of the Post-Season Championship Tournament, except for a regularly scheduled contest, is not permitted for seven calendar days prior to the Post-Season Championship, except in the case of the host school.

Rationale: Teams and players are currently not allowed to warmup on the site of the tournament. The Tennis Advisory Committee believes that this is an outdated rule that unfairly punishes out of Phoenix schools. Tennis Coaches were surveyed and 120 out of 138 (87%) voted to change the rule.

On a motion made, seconded, and carried the Executive Board <u>denied</u> the above policy and procedure amendment.

EXCEPTION – ARTICLE 14.4 – NONSCHOOL PARTICIPATION

Chaparral High School is looking for an exception to 14.4 for a student athlete. This student would like to compete on Canada's 15U National Softball Team in the Pan American Games, March 19-30 in Mexico. Our exception request is to allow her to participate on this national team and retain eligibility or allow the student to participate for Chaparral after the games have been completed and she returns to school.

After review of the written and oral information provided by Chaparral High School Athletic Director, Jack Bagley, on a motion made, seconded, and carried the Executive Board **approved** the above request for the student to participate on her National Softball Team.
