## **SCHOOL VIOLATIONS**

**CHAPARRAL HIGH SCHOOL** – Scottsdale Unified School District

Rule: Article 15. Student Eligibility Rules, Section 10 Transfer Rule (15.10.5)

# **Reported Violation:**

On 1/27/25, an in-season transfer student was put into the JV boys' soccer game vs Horizon. Seeing this the varsity coach immediately pulled the athlete out of the game 10 minutes into the game. The game was forfeited, and the coach's contract will not be renewed.

# **Schools Corrective Action:**

Contest forfeited. Soccer staff in-serviced again on Article 15. Equipment manager reminded uniforms are not given to ineligible athletes. JV coach not renewed.

## **Executive Board Action:**

The Executive Board, in accordance with Article 16, Section 1 of the AIA Bylaws, placed the Chaparral High School **Boys' Soccer Program** on **Advisement** for one year 3/17/25-3/17/26. The Executive Board was appreciative of SUSD and Chaparral for taking action and resolving the situation.

Nathan Slater and Matt Belden abstained.

#### CASTEEL HIGH SCHOOL - Chandler Unified School District

Rule: Article 17. Coaches and Coaching, Section 4 Coach's / Sponsor's Code of Ethics (17.4.3.7)

#### **Reported Violation:**

Head coach made statements to AZ Central interview blaming referees for championship loss.

# **Schools Corrective Action:**

School AD will include bylaw 17.4.3.7 in all preseason coaches meetings as well as coach in questions completing NFHS Sportsmanship Course.

# **Executive Board Action:**

The Executive Board, in accordance with Article 16, Section 1 of the AIA Bylaws, <u>accepted</u> the report from Casteel High School.

## **CAMP VERDE HIGH SCHOOL** – Camp Verde Unified

Rule: Article 15. Student Eligibility Rules, Section 10 Transfer Rule (15.10.2)

# **Reported Violation:**

In the March 4<sup>th</sup> Varsity baseball game, student athlete batted 1 time. After seeing this, the AD contacted the coach, and the student was removed from the game. The students' hardship had been submitted but not approved. He should have not played due the 50% transfer rule.

# **Schools Corrective Action:**

Met with the baseball coaches to ensure processes are in place so details like this are not overlooked again. Contest forfeited.

## **Executive Board Action:**

The Executive Board, in accordance with Article 16, Section 1 of the AIA Bylaws, placed the Camp Verde High School **Baseball Program** on **Warning** for one year 3/17/25-3/17/26.

<u>DESERT VISTA HIGH SCHOOL</u> – Tempe Union High School District Rule: Article 14. General Provisions, Section 4 Nonschool Participation (14.4.1)

#### **Reported Violation:**

On Friday, February 21st, at 9:08 p.m., the Desert Vista AD was contacted by Highland High School's AD, who informed him that the Highland Principal had observed Desert Vista boys' basketball players arriving at a YMCA facility wearing DV uniform bottoms with the intent to participate in a game. Upon receiving this information, the Desert Vista AD reviewed photos and video footage provided by Highland to verify the students involved. Initial reports indicated that two student-athletes participated, but upon further review, it was determined that three student-athletes had played in the game. Another significant concern in this situation is that as the game began, the YMCA coach was informed by the Highland Principal that AIA rules prohibit student-athletes from participating in outside competition during the season. Despite being made aware of the rule, the YMCA coach did not prevent the Desert Vista players from participating. Instead, the players were encouraged to participate, creating an unfortunate situation where they violated AIA bylaw 14.4.1. After the game, tensions escalated as spectators and others confronted the students, accusing them of violating eligibility rules. It is important to note that Desert Vista's coaching staff had previously communicated to the team and their parents that participating in any outside games during the season is not permitted. Unfortunately, the student-athletes mistakenly believed that because it was a YMCA league and not a formal club team, the rule did not apply—a misunderstanding that was reinforced by the YMCA coach's inaction. While the students ultimately made the decision to play, they did so under the impression that no rules were being broken.

## **Schools Corrective Action:**

Upon confirming the violation, the Desert Vista AD immediately addressed the situation the following morning at practice. Two of the three involved student-athletes were informed that they were now ineligible per AIA bylaw 14.4.1, with the third being notified shortly thereafter. Additionally, the entire team was once again reminded of the rule prohibiting outside competition during the season and the serious consequences of violating AIA regulations. As a result of the violation, Desert Vista will have to forfeit one regular season game and the play-in game from Friday, Feb. 21st against Shadow Ridge High School. These are the games in which the ineligible student-athletes participated. Additionally, per AIA regulations, Desert Vista is ineligible for continuing in the 6A state playoffs scheduled.

To prevent similar situations in the future, Desert Vista has implemented the following corrective actions:

- Coach Training and Reinforcement: The Desert Vista Athletic Director held a meeting with all Desert Vista coaches to thoroughly review AIA bylaw 14.4.1, ensuring they fully understand the rule and reinforcing their responsibility to communicate and enforce it with their teams.
- 2. Team and Parent Communication: Following this meeting, Desert Vista administration communicated with parents informing them of the bylaw and its implications to ensure full transparency and understanding.
- 3. Enhanced Compliance Measures: Moving forward, AIA eligibility rules will continue to be emphasized before the season and throughout, emphasizing the importance of compliance and the consequences of violations.
- 4. Collaboration with Outside Organizations: While Desert Vista does not have authority over non-school programs, efforts will be made to educate external organizations about AIA rules to reduce the likelihood of similar situations occurring.

Desert Vista High School deeply regrets this situation and acknowledges the consequences of the violation. While we take full responsibility for ensuring our student-athletes understand and comply with AIA regulations, it is unfortunate that external influences contributed to this misunderstanding. We remain committed to upholding the integrity of high school athletics and ensuring all eligibility rules are followed moving forward.

# **Executive Board Action:**

The Executive Board, in accordance with Article 16, Section 1 of the AIA Bylaws, placed the Desert Vista High School **Boys' Basketball Program** on **Warning** for one year 3/17/25-3/17/26.

<u>GREENWAY HIGH SCHOOL</u> – Glendale Union High School District Rule: Article 14. General Provisions, Section 4 Nonschool Participation (14.4.1)

#### **Reported Violation:**

I received an email on 2/20/25, stating that one of our varsity girls' soccer players had participated with a club soccer team while our season was still in session. I called the mother who is the parent as well as the 1<sup>st</sup> year head coach of the club team in questions. The mother told me that she participated in a scrimmage against a boys' team on Thursday, February 6<sup>th</sup>. Our regular season games were over, but our season was not as we played Ironwood Ridge in a play-in game on Thursday February 13<sup>th</sup>. It was determined that the student did not practice with the club team during the season, but did play in the scrimmage on 2/6/25.

When speaking with our Head Girls Soccer Coach, he was aware that the mother was the Head Coach of the Club Team and he specifically told her and her daughter at the Pre-Season Meeting, that she can't play or practice with them until their season was completely done. I am not sure if she though it was the regular season, but she was Ineligible for the Play-In game and still played.

# **Schools Corrective Action:**

We do put an emphasis at our pre-season parent meetings, both full parent and individual sport, on telling parents that once the season of sport beings, the athletes are not allowed to participate in any club sport activities of the same sport. It seems like we need to let them know that includes all playoffs as well and not just the regular season.

### **Executive Board Action:**

The Executive Board, in accordance with Article 16, Section 1 of the AIA Bylaws, placed the Greenway High School **Girls' Soccer Program** on **Warning** for one year 3/17/25-3/17/26.

TREVOR G BROWNE HIGH SCHOOL – Phoenix Union High School District Rule: Article 14. General Provisions, Section 4 Nonschool Participation (14.4.1)

#### **Reported Violation:**

Student athlete was posted on Instagram through legacyyouthsports regarding being "Player of the Game" in the "Kiss the Rock Basketball Tournament" during the weekend of 02/08/2025. This was with the club team AZ Flight during his regular high school sports season.

## **Schools Corrective Action:**

The student has been removed from the program and any affiliation with the boys' basketball program. In addition, we have added more information regarding the rule for our parent meeting to make sure everyone is informed.

# **Executive Board Action:**

The Executive Board, in accordance with Article 16, Section 1 of the AIA Bylaws, placed the Trevor G Browne High School **Boys' Basketball Program** on **Warning** for one year 3/17/25-3/17/26.

## ANDRADA HIGH SCHOOL - Vail Unified School District

Rule: Article 34. Wrestling Section 1 Rules (34.1.5)

Rule: Article 17. Coaches and Coaching Section 4 Coach's/Sponsor's Code of Ethics (17.4.3.1)

## **Reported Violation:**

Coach intentionally entered incorrect weights into the OPC system to circumvent the system in place to protect wrestlers from being subjected to extreme weight loss demands from coaches. This would potentially allow him to tell his wrestlers to lose weight and compete at a weight class they would not have been eligible to compete in had he entered their correct certified weights at prior weigh-ins. This could have allowed his team to potentially gain a competitive edge in team scoring and dual meet competition the AIA requires all head coach's to record the actual weights from the official weigh-in sheets that are certified at each competition. No athlete was found to be knowingly involved in this incident and all wrestled at their certified weights.

# **Schools Corrective Action:**

This was discovered by the AD as part of our normal audit of data entered by the coach. The coach's employment at our school has been ended as of 1/24/2025 and he was not allowed to have team contact or to attend competitions while the investigation was being conducted.

# **Executive Board Action:**

The Executive Board, in accordance with Article 16, Section 1 of the AIA Bylaws, placed the Andrada High School **Wrestling Program** on **Warning** for one year 3/17/25-3/17/26.

  - 20.4.4.1 The varsity scrimmage shall be scheduled the week prior to the AIA date of competition; individual players must have participated in at least ten seven practice sessions and completed the requirements of AIA Bylaw 41.5 Heat Acclimatization

**Rationale:** Because the season starts in just two weeks the current ten practices does not allow for any days except maybe a Saturday for a scrimmage and Badminton is an indoor sport with little running therefore seven practices oppose to ten make sense to the Badminton community.
