9. SCHOOL VIOLATIONS

(A) Rule: Article 15. Student Eligibility Rules, Section 7 Physical Examination Rule / Section 8 Parental or Legal Guardian Consent Rule

15.7 PHYSICAL EXAMINATION RULE

- 15.7.1 A student shall not be allowed to practice or compete in interscholastic athletics until there is on file with the principal or his/her designee a record of a preparticipation physical examination (PPE) performed by a doctor of medicine (M.D.), an osteopathic physician (D.O.), a naturopathic physician (N.D., N.M.D.), a certified registered nurse practitioner (N.P.) licensed to practice, a certified physician's assistant (PA-C) registered by the Joint Board Of Medical Examiners and the Osteopathic Examiners in Medicine and Surgery, or a certified chiropractic sports physician (CCSP). The physical examination for the following school year shall be given on or after March 1. The physical examination on file shall be signed by one of the aforementioned medical providers and shall state that, in the opinion of the examining provider, the provider did not find any medical reason to disqualify the student from practice or competition in athletic contests. The principal or his/her designee, if deemed advisable, may require a student to be reexamined.
- **15.8** PARENTAL OR LEGAL GUARDIAN CONSENT RULE Parental or legal guardian consent is required before a student can be eligible to practice or compete in interscholastic competition. All students shall have on file with the principal or his/her designee appropriate permission in which the parent or legal guardian authorized participation.

(1) MOUNTAIN RIDGE HIGH SCHOOL – Deer Valley Unified School District

Reported Violation:

The boys' beach volleyball coach had printed a list of students from RMA that were cleared to tryout. On the day of try-outs he had grabbed his camp list and brought it with him to the courts and used this as his cleared athlete list. As soon as he realized that he had the wrong list he immediately corrected his actions and used the list provided to him from RMA.

Schools Corrective Action:

The coach received formal discipline from administration. The coach was re-trained on policies and procedures for student-athlete tryouts. The coach will receive his list of cleared athletes directly from the athletic office.

Prior Violation(s):

(B) Rule: Article 17. Coaches and Coaching, Section 3 Completion of Contest – Ejection of Coach

17.3 COMPLETION OF CONTEST – EJECTION OF COACH

- 17.3.1 When a coach is ejected from a contest, a properly constituted school administrator or assistant coach shall direct and supervise the team during the remainder of the contest. If no properly constitute school administrator or assistant coach is available to direct the team, the official shall declare the contest a forfeit.
 - 17.3.1.1 The ejected coach shall immediately vacate the premises, meaning the coach must leave the stadium, gymnasium or other competition area.
 - 17.3.1.1.1 Premises are defined as the total area of contest and spectators. The ejected coach may not remain to watch the contest.

(1) HIGHLAND PREP HIGH SCHOOL – Highland Prep Academies

Reported Violation:

Head Coach used a play calling app to communicate with the coaching staff during a game in which he was suspended by the AIA and Highland Prep Surprise. Coach was explicitly told AIA Bylaw 17.3 and was informed of his suspension due to behaviors exhibited during contests. Coach no longer employed at the school due to his insubordination and lack of ethics in regards to this situation. Coach was fired immediately upon discovery.

Schools Corrective Action:

Highland Prep's school administration were advised that Highland Prep's Head Football Coach was reportedly making play calls while serving suspension during Friday Night's loss to Veritas Prep. The report was substantiated, and I requested that report to Highland Prep to meet with School Principal and myself after his work day. Coach was placed on suspension from all team activities due to not being able to meet until end of workday. The corrective action meeting took place at 7:30 a.m. this morning and Coach was removed from his coaching position with Highland Prep. Highland Prep will communicate a corrective action plan to the AIA that will include having 'all' coaches trained on AIA Bylaws.

Prior Violation(s):

- (C) Rule: Article 15. Student Eligibility Rules, Section 10 Transfer Rule
 - **15.10** <u>TRANSFER RULE</u> Except as stated in 15.10.6, after enrolling and attending one or more classes, a student changing enrollment from one school (sending school) to another school (receiving school) shall be considered a transferring student. For information and record keeping purposes, the receiving and sending school shall reasonably cooperate and complete Form 550.
 - 15.10.1 In team sports, a student shall be ineligible for all power ranked contests at the varsity level until after the first 50% of the maximum allowable Power Rankings regular season contests in those sports in which the student participated during the twelve (12) months immediately preceding the season in which the student is seeking eligibility. In sports permitting invitationals/tournaments, the student shall be ineligible for the first invitational/tournament. Participation is defined as a student participating in the sport during a regular season game as is specified by the AIA standardized calendar.
 - (1) PINNACLE HIGH SCHOOL Paradise Valley Unified School District

Reported Violation:

An intra-district transfer student who played flag football last spring should have been sitting out for the first half of the season was deemed eligible and played in this game. This was an oversight within the athletic department because Pinnacle did not participate within the AIA last year but played organized flag football vs another district within the past 12 months.

Schools Corrective Action:

Contests forfeited. The athletic director and the district athletic director will now conduct a joint review of all student-athlete transfers to determine eligibility. This process has been instituted to prevent a single point of failure.

Prior Violation(s):

(D) Rule: Article 14. General Provisions, Section 5 Individual Competition

14.5 INDIVIDUAL COMPETITION

14.5.1 A student competing as an individual and in his/her name shall not be coached by, transported by, financed by, or chaperoned by the school or school personnel. He/She shall not be identified as a representative of the school. He/She shall not use any school equipment when competing.

(1) MONUMENT VALLEY HIGH SCHOOL – Kayenta Unified

Reported Violation:

The coach requested a bus to transport the cross-country team to a community free run event. The use of district transportation for this purpose constitutes a violation. The head coach did not disclose that the team would be participating in a community event and instead indicated that the bus was requested for a practice run at another trail location. This occurred during the season, one week prior to the teams' first competition.

Schools Corrective Action:

As a corrective action, the head coach will review AIA bylaws and district policies regarding transportation and participation in community events and attend a brief meeting to ensure understanding of proper procedures for event disclosure and bus requests. Moving forward, all transportation requests must be reviewed and approved by the athletic director with full disclosure of the event's purpose. The head coach is on suspension until a final decision is made by the AIA Executive Board meeting on October 20.

Prior Violation(s):

September 9, 2025. Warning – Football Program. Article 15.7 – Physical Examination.

- (E) Rule: Article 15. Student Eligibility Rules, Section 10 Transfer Rule
 - **15.10** <u>TRANSFER RULE</u> Except as stated in 15.10.6, after enrolling and attending one or more classes, a student changing enrollment from one school (sending school) to another school (receiving school) shall be considered a transferring student. For information and record keeping purposes, the receiving and sending school shall reasonably cooperate and complete Form 550.
 - 15.10.4 A transfer student who plays only in sub-varsity competitions shall have immediate eligibility but is ineligible to participate at the varsity level in regular season, tournaments, and post-season competitions for the season in that sport. A decision to participate only at sub-varsity levels must be made prior to the season of competition.
 - (1) CASTEEL HIGH SCHOOL Chandler Unified School District

Reported Violation:

Students who signed sub varsity declarations participated in our varsity football game on 9/16/25. Head coach played these two players under the impression the 4pm game time was for JV game.

Schools Corrective Action:

Contests forfeited. The school will handle discipline internally. Coach will review entire schedule with Athletics Office and plan accordingly.

Prior Violation(s):

(F) Rule: Article 24. Football, Section 5 Number of Games in Season

24.5 NUMBER OF GAMES IN SEASON

- 24.5.3 No player shall participate in more than five (5) quarters per week, excluding qualifying and post-season tournaments.
- (1) VALLEY VISTA HIGH SCHOOL Dysart Unified School District

Reported Violation:

On September 18th Valley Vista played players for more than the allotted 5 quarters per week. Due to low numbers, Valley brought a few players from the 9/10 team as emergency players for the JV game. One of our own coaches realized that some of the players ended up playing more than 5 quarters and reported it to me. The players played more than 5 quarters because when some players had to come out with injuries or fatigue, coaches subbed available players with.

Schools Corrective Action:

I have addressed this with our head coach so that it does not happen again. We will designate someone to track the quarters on the sideline. Eliminating one of our lower-level programs so that athletes don't have to dress in multiple games.

Prior Violation(s):

(G) Rule: Article 16. Penalties and Appeals, Section 2 Ineligible Player

16.2 <u>INELIGIBLE PLAYER</u>

- 16.2.1 When an ineligible player(s) participates in a contest, the member school must automatically forfeit all contests in which the ineligible player(s) participated.
- (1) CESAR CHAVEZ HIGH SCHOOL Phoenix Union High School District

Reported Violation:

On September 25th I was informed by the AD at South Mountain that two of our varsity girls volleyball players participated in the varsity game against Maryvale on September 23rd. both athletes had completed the appropriate transfer forms and were subject to the 50% sit-out rule. The game against Maryvale was intended to be their ninth and final game to sit out, in accordance with AIA transfer regulations. However, upon review, it was determined that their participation occurred one game too early. The error stemmed from a misunderstanding by our new varsity head coach, who believed that tournament matches counted toward the 50% sit-out requirement. She has since acknowledged the mistake and expressed sincere regret. She recalled prior discussions regarding transfer rules but did not recall that tournament matches do not count toward the sit-out total.

I met with the coach in person and addressed the issues and provided her with a formal letter of direction. Based on our conversation and her conduct, I do not believe the decision to play the athletes was intentional or made for any competitive advantage. Nevertheless, we acknowledge the error and understand that the game will need to be forfeited in accordance with eligibility rules.

Schools Corrective Action:

Contest forfeited. I met with my varsity girl's volleyball coach in person on 9/26/25. I gave her a formal letter of direction. I also sent an email out to all coaches reiterating the AIA transfer rules and attached a copy of the bylaws.

Prior Violation(s):

- (H) Rule: Article 15. Student Eligibility Rules, Section 15 International Student Eligibility
 - 15.15 <u>INTERNATIONAL STUDENT ELIGIBILITY</u> Prefatory Statement: In an effort to preserve and promote interscholastic competitive opportunities for Arizona students and further the goals of competitive fairness, and recognizing the concerns of AIA member schools related to displacement of Arizona students by students from foreign countries, the following bylaw addresses the interscholastic eligibility status of international students attending an AIA member school:
 - 15.15.1 Foreign Exchange Students A foreign exchange student is a student that is in the U.S. under a J-1 Visa, and who is placed in a school by an educational exchange program approved by the Council on Standards for International Educational Travel (CSIET). A foreign exchange student is eligible at a school in the attendance zone of the home in which the student is placed. A foreign exchange student must meet all other eligibility requirements and is eligible for a maximum of one school year.
 - (1) CHAPARRAL HIGH SCHOOL Scottsdale Unified School District

Reported Violation:

A foreign exchange student with an F1 vista has played in varsity badminton matches.

Schools Corrective Action:

Contest forfeited. we will require the registrar to inform administration if foreign exchange students want to play sports as well as coaches. Coaching training on foreign exchange students and better communication with coaches.

Prior Violation(s):

(I) Rule: Article 14. General Provisions, Section 2 Practice

14.2 PRACTICE

- 14.2.2 AIA member schools may only practice with or scrimmage against their own school team during the interscholastic season of that sport as set forth in the appropriate Article of the Sport Policy.
- (1) JOSEPH CITY HIGH SCHOOL Joseph City Unified

Reported Violation:

Joseph City football played Sedona Red Rock in a pre-season scrimmage. Sedona Red Rock is in their first year of their program, restarting after many years. At some point in the scrimmage, Sedona Red Rock was unable to field 9 healthy offensive players. The coaches communicated with each other, along with the officials and Joseph City agreed to loan a player to snap the ball for Sedona Red Rock's offensive possession. This decision was done with the intent of helping a new program, and not to gain any competitive advantage.

Schools Corrective Action:

Admin and coaches had a discussion over bylaw 24.3.1.2. This bylaw was interpreted incorrectly and education to all coaching staff and administration has been completed.

Prior Violation(s):

- (J) Rule: Article 15. Student Eligibility Rules, Section 10 Transfer Rule
 - **15.10** <u>TRANSFER RULE</u> Except as stated in 15.10.6, after enrolling and attending one or more classes, a student changing enrollment from one school (sending school) to another school (receiving school) shall be considered a transferring student. For information and record keeping purposes, the receiving and sending school shall reasonably cooperate and complete Form 550.
 - 15.10.1 In team sports, a student shall be ineligible for all power ranked contests at the varsity level until after the first 50% of the maximum allowable Power Rankings regular season contests in those sports in which the student participated during the twelve (12) months immediately preceding the season in which the student is seeking eligibility. In sports permitting invitationals/tournaments, the student shall be ineligible for the first invitational/tournament. Participation is defined as a student participating in the sport during a regular season game as is specified by the AIA standardized calendar.
 - (1) **RAYMOND S. KELLIS HIGH SCHOOL** Peoria Unified School District

Reported Violation:

Student enrolled at RSK on January 9th and completed a 550 form on March 24, 2025. This process resulted in student being ineligible for 50% of the season due to transfer rule. RSK head football coach was hired after student enrolled and unaware of student eligibility status. Previous AD resigned just days before school started, new AD was hired and began working on August 18th. Nothing was left or shared by the previous AD with the new AD. On September 10th, another RSK coach informed both new AD and new Coach that student was a transfer and may be ineligible. This information prompted all parties to investigate, where we discovered his eligibility status. On September 11th, student and his parents were notified of his status. District AD was also notified of the violation on this date and directed RSK to complete a violation form.

Schools Corrective Action:

Verification Procedures

- Implementation of a mandatory eligibility clearance checklist for all transfer students prior to participation in practice or competition.
- Require administrative sign-off (Athletic Director and Registrar) confirming that AIA transfer paperwork has been fully processed and approved.

Communication Protocols

- Communicate to coaches via weekly eligibility updates from the Athletic Director prior to games.
- Provide ongoing reminders at coaches' meetings regarding the importance of eligibility compliance.

Training and Accountability

- Conduct annual training for all coaches on AIA eligibility rules, with emphasis on transfer regulations. Afterwards, coaches are required to sign an eligibility compliance acknowledgment form each season.
- Hold staff accountable for violations through formal review if procedures are not followed.
- Randomly spot-check rosters prior to contests to confirm only eligible athletes are listed.

Oversight and Auditing

· Implementation of a pre-season and mid-season eligibility audit conducted by the Athletic Director or designee.

Parent/Student Communication

· Provide parents and transfer students with a clear eligibility timeline and checklist upon enrollment.

Prior Violation(s):

(K) Rule: Article 15. Student Eligibility Rules, Section 3 Enrollment Rule

15.3 ENROLLMENT RULE

- 15.3.1 Only students enrolled at a member school in grades 9 through 12, shall be eligible for interscholastic competition, team practices and tryouts. For purposes of this rule, a student's school of enrollment is defined as the school where the student's permanent grades/records are maintained and from which the student will be eligible to graduate. (Emergency Legislation Ex. Brd 3/21/22).
 - 15.3.1.1 <u>EXCEPTION</u>: A home school student may be eligible if said student is in compliance with A.R.S. §15-802.01
- (1) CORONADO HIGH SCHOOL Scottsdale Unified School District

Reported Violation:

We played a home schooled student that was out of boundaries and we didn't have proof of home school affidavit. This violation took place during the school year of 2024-2025.

Schools Corrective Action:

Contest Forfeited. Provide training to all coaching staff to communicate with the athletic administration once they discover that they have a home schooled student. Any student that is new to the school needs to be cleared through RMS and indicate that they are home schooled. The athletic director will follow district policy and confirm affidavit and home school curriculum.

Prior Violation(s):

(L) Rule: Article 14. General Provisions, Section 4 Nonschool Participation

14.4 NONSCHOOL PARTICIPATION

14.4.1 A student who is a member or becomes a member of a school team shall not practice, have practiced or compete with any other group, club, organization, association, etc., in that sport, or derivative of that sport that is not already sanctioned by the AIA during the interscholastic season of competition. This rule applies to the following team sports: football, flag football, baseball, basketball, volleyball, soccer, softball, track relay and swimming relay teams. For purposes of this rule, the interscholastic season of competition shall begin on the competition date as set in the policies and procedures of each sport and conclude with that particular team's final game. Any student violating the above rule shall forfeit his/her eligibility for a minimum of the balance of the season for that sport or up to a maximum of one calendar year.

<u>DETERMINATION</u>: An individual student may take private lessons anytime except during the school day or during school practice sessions. For purposes of this rule, individual private lesson means, and is limited to, no more than two distinct students and one coach/instructor. Schools shall not pay for, arrange or in any way provide these individual private lessons. Individual private lessons shall not be used to circumvent or evade the non-school participation rule and any such use of private lessons will be considered a violation of the non-school participation rule. (Ex. Bd. 2/18/03).

(1) DOUGLAS HIGH SCHOOL – Douglas Unified

Reported Violation:

JV volleyball player from our volleyball program participated in a volleyball game in Agua Prieta, Sonora, Mexico on September 7, 2025. We acknowledge that this constitutes a violation of the AIA rules and procedures. Upon being informed of the violation, the AD held a follow-up meeting with the student athlete and parent on Tuesday, October 7. As a result of the investigation, the athlete was immediately removed from the team.

Schools Corrective Action:

The student athlete and parent previously attended a preseason meeting where they reviewed and acknowledged the polices and procedures of the Douglas Unified School District, Douglas Athletics and AIA. Athlete removed from team. AD will conduct another meeting with all student athletes and parents to review AIA bylaws and reinforce team expectations. AD will also meet with the coaching staff to review district policies and AIA procedures, and to emphasize the importance of full compliance with all bylaws.

Prior Violation(s):

14. WRESTLING OPC WEIGHT CERTIFICATION

Weight Certifications may begin on the first day of practice.

Rationale: Weight certifications are intended to, as closely as possible, capture that athlete's natural weight. Using this day as the start will allow coaches to begin the process as soon as possible, however, most schools will wait until closer to their first match to complete the certifications to allow for the weight adjustments from the first few weeks of practice. I see no detriment to the athletes with this option.
